RELATING TO TAXATION.

TCI/AGR, FIN

Amends the transient accommodations tax to require that the first amount of tax revenues deposited to the credit of the tourism special fund and subsequently allotted among specific funds. (SD1)




Testimony submitted will be placed on the Legislative Web site after the hearing adjourns. This public posting of testimony on the Web site should be considered when including personal information in your testimony.
