<u>Testimony</u>	Authorizes the counties to conduct criminal history record checks on taxicab drivers and applicants for taxicab driver's certificates.

<u>SB 698</u>	RELATING TO THE RENTAL MOTOR VEHICLE AND TOUR VEHICLE SURCHARGE TAX.	TIA/CPN, WAM
<u>Testimony</u>	Increases the rental motor vehicle and tour vehicle surcharge tax.

<u>SB 1611</u>	RELATING TO HIGHWAYS.	TIA/CPN, WAM
<u>Testimony</u>	Increases the state liquid fuel tax; state vehicle registration fee; state vehicle weight fee; and rental motor vehicle surcharge tax. Provides funding for a six-year comprehensive modernization program.
