RELATING TO PUBLIC SAFETY.

PSM, WAM/JGO

Authorizes judiciary fees on parolee and probationer's prison transfer applications to be deposited into the probation services special fund. Authorizes full-time coordinator position for the state council for interstate adult offender supervision to be paid from the probation services special fund. Limits expenditure from the probation services special fund to \$400,000 every fiscal year.

Decision making meeting only, no public testimony will be accepted.
