<u><a href="#">SB 1449</a></u> <u><a href="#">Proposed SD1</a></u> <u><a href="#">Status</a></u>	RELATING TO GENERAL EXCISE TAX. Proposed SD1: Amends the general excise tax return filing and payment procedures to require periodic estimated payments and one annual return.	WAM
<u><a href="#">SB 1461</a></u> <u><a href="#">Proposed SD1</a></u> <u><a href="#">Status</a></u>	RELATING TO TAXATION. Proposed SD1: Requires all persons required to electronically file and pay federal taxes to electronically file and pay state taxes. Accelerates the filing and payment due dates for general excise, transient accommodation, fuel, cigarette, and rental motor vehicle and tour vehicle surcharge taxes.	WAM
