(HSCR557) Status

Authorizes the Department of Transportation to adopt rules relating to safety measures, security requirements, and shipping activities for the

purpose of protecting and ensuring the general public interest and safety of persons and vessels in the commercial harbors belonging to

or controlled by the State.

RELATING TO HAWAII COMMUNITY DEVELOPMENT

Allows Chairperson of DHHL and director of city and county

department of planning and permitting to designate a representative to

serve on HCDA.

WLO

Allows 999-year homestead leases to be assigned to land trusts that are created for purposes of managing and holding the homestead leasehold

estate for the benefit of the lessee and lessee's family members.
