RELATING TO THE UNIVERSITY OF HAWAII.

HRE/WTL, WAM

Allows the UH Board of Regents to adopt administrative rules to regulate public and commercial activities at and within the Mauna Kea lands, or the lands UH leases from the Board of Land and Natural Resources. Requires the BOR to establish procedures to enforce these rules. Allows UH to assess and collect administrative fines for violations of these rules. Establishes the Mauna Kea Management Special Fund for the deposit and use of these revenues. (HB1174 HD3)

Decision Making to follow, if time permits.

- By Email: Testimony may be emailed if less than 5 pages in length, to the Committee at WTLTestimony@Capitol.hawaii.gov. Please indicate the measure, date and time of the hearing. Email sent to individual offices or any other Senate office will not be accepted.
- LATE TESTIMONY – Testimony received after the testimony deadline will be posted on the legislature's website after the hearing ends. If you are testifying in person, please bring twelve (12) copies of your testimony to the hearing room (229) and give to the committee clerk PRIOR to the start of the hearing.

Please note: If you submit your written testimony after 3:45 p.m. the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.

If you require special assistance or auxiliary aids or services to participate in the public hearing process (i.e., sign or foreign language interpreter or wheelchair accessibility), please contact the committee clerk 24 hours prior to the hearing so arrangements can be made.
