<u>SB 580</u>	RELATING TO FORFEITURE.	WTL, JGO
<u>Testimony</u>	Clarifies that the forfeiture laws apply to violations of conservation and resources statutes and rules and to protection of caves, historic preservation, and the Kaho‘olawe island reserve.	
<u>Status</u>		
<u>SB 582</u>	RELATING TO KULEANA LANDS.	WTL, JGO
<u>Testimony</u>	Makes the office of Hawaiian affairs the trustee of any unclaimed kuleana lands. Prohibits quieting title to kuleana lands or claiming kuleana lands by adverse possession.	
<u>Status</u>		
<u>SB 1085</u>	RELATING TO CEDED LANDS.	WTL, JGO
<u>Testimony</u>	Prohibits the board of land and natural resources from selling, exchanging, or otherwise alienating ceded lands in the public land trust.	
<u>Status</u>		
<u>SB 475</u>	RELATING TO LANDS CONTROLLED BY THE STATE.	WTL, JGO
<u>Testimony</u>	Prohibits the sale or exchange of certain public lands considered to be ceded lands. Expires on decision of U.S. Supreme Court on pending appeal of related case.	
<u>Status</u>		
<u>SB 476</u>	RELATING TO LANDS CONTROLLED BY THE STATE.	WTL, JGO
<u>Testimony</u>	Requires two-thirds majority vote of the legislature to adopt concurrent resolution to sell or exchange certain public lands.
