<u>HB 366, HD2</u> <u>(HSCR703)</u> <u>Testimony</u> <u>Status</u>	RELATING TO MANTA RAYS. Establishes fines and penalties for any person who knowingly captures or kills a manta ray within state marine waters. Provides an exception for special permits granted for scientific, education, management, or propagation purposes. (HB366 HD2)	WTL, JGO
<u>HB 899, HD1</u> <u>(HSCR941)</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS. Clarifies and strengthens the Office of Hawaiian Affairs' bond authority. Effective 07/01/2020. (HB899 HD1)	WTL, WAM
<u>HB 921, HD1</u> <u>(HSCR666)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PUBLIC LANDS. Allows 999-year homestead leases to be assigned to land trusts that are created for purposes of managing and holding the homestead leasehold estate for the benefit of the lessee and lessee's family members. Allows trustee of land trust to assume obligations of lessee. (HB921 HD1)	WTL, WAM
<u>HB 1552, HD2</u> <u>(HSCR934)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PUBLIC LANDS. Authorizes DLNR to issue long-term residential leases to qualified persons in state living parks. Establishes living park planning councils to develop state living park master plans to ensure the living park achieves its purpose and goals. Takes effect July 1, 2020. (HB1552 HD2)	WTL, WAM
<u>HB 1665, HD1</u> <u>(HSCR943)</u> <u>Testimony</u> <u>Status</u>	RELATING TO HAWAIIAN FISHPONDS. Prohibits the sale of public lands on which government-owned Hawaiian fishponds are located. Effective July 1, 2020. (HB1665 HD1)	WTL, WAM

When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.
- By Web: Testimony may be submitted online if less than 4MB in size, at <http://www.capitol.hawaii.gov/emailtestimony>.
- By Email: Testimony may be emailed if less than 5 pages in length, to the Committee at WTLTestimony@Capitol.hawaii.gov. Please indicate the measure, date and time of the hearing. Email sent to individual offices or any other Senate office will not be accepted.
- LATE TESTIMONY – Testimony received after the testimony deadline will be posted on the legislature's website after the hearing ends. If you are testifying in person, please bring twelve (12) copies of your testimony to the hearing room (229) and give to the committee clerk PRIOR to the start of the hearing.

Please note: If you submit your written testimony after 3:00 p.m. the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.

If you require special assistance or auxiliary aids or services to participate in the public hearing process (i.e., sign or foreign language interpreter or wheelchair accessibility), please contact the committee clerk 24 hours prior to the hearing so arrangements can be made.
