Comments:

As a small business owner at Aloha Stadium Swap Meet, I'm opposed to re-appointment of current Stadium Authority Members prior to SB382 implementation. I've attended many Stadium Authority Board Meetings and documented issues facing Swap Meet Vendors. I've provided current board members with information relative to performance problems with Centerplate--the Swap Meet Management Contractor and attended meetings where Board Members applauded their efforts, even though proven counterproductive to healthy relations with Vendors and loss of income for the State. Some Board Member comments during meetings reflect individuals that have little knowledge of the Swap Meet or compassion for Vendors; who provide over 60% of the Stadium's income. SB382 addresses appointment of Board Members and should include an appointee as a Vendor Advocate, since Centerplate has failed to do so and Board Members failed to hold them accountable.
