Q: Conflicts of interest? Surmountable?

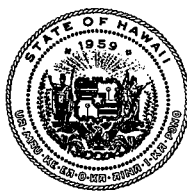
A: Currently AMR Medical Director. If committee were to make a recommendation that affected EMS contracts, I would recuse myself.
