RIFLERY, ARCHERY, AND HUNTING ACTIVITIES.**

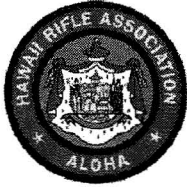
Chair Ito, Vice Chair Har and Members of the House Committee on Water, Land, & Ocean Resources.

The Department of Business, Economic Development and Tourism (DBEDT) cannot support HCR 174 / HR 138 due to budgetary concerns. This resolution requests that DBEDT convene a working group to research and report on the viability of attracting tourists to Hawai'i to participate in riflery, archery and hunting activities. It further requests the department to investigate and study the feasibility of creating a market in the tourism industry by 1) identifying the challenges, barriers and opportunities to promote riflery, archery and hunting as a niche market in tourism; 2) reviewing existing laws and rules pertaining to riflery, archery and hunting; and 3) recommending any changes to existing laws and rules to promote riflery, archery and hunting as a niche market in the tourism industry.

While there may be an opportunity to enhance Hawai'i's brand and image by further developing a tourism niche market for hunting, riflery and archery in the islands, the department does not have the personnel nor the financial resources needed to undertake this study.

To fully develop a plan that would enable the State to explore the opportunities and provide recommendations to the Legislature, a budgetary appropriation would be required. As this has not been taken into consideration in the Executive Biennium Budget, we cannot support this measure.

Honorable Chair Ito, Vice Chair Har, Members,

HRA is in strong support of this Resolution and hopes to participate with the working group.

The Resolution seeks to promote a severely underdeveloped tourism niche. While most of the U.S. is buried under winter, we enjoy year round shooting, archery, and hunting opportunities. Only a small percentage of the potential market is even aware that such activities are available here. Not enough ranges are available here yet, and private landowners show amazingly little interest.

There is a misconception among the tour industry that offering recreational opportunities of this nature will cause other tourists to turn away. On the contrary, the potential net gain in tourism is tremendously positive.

There are those, like the opponents of the Superferry, who don't want to share their hunting opportunities. Most of those hunters don't even bother to buy a hunting license, so we lose Pittman-Roberson funds to mainland states that have learned that controlling poaching is a cornerstone of a good fish and game program.

Some of our HRS 134 is decidedly unfriendly to potential visitors who would bring their firearms with them, and needs to be looked at by such a working group.

Comments:

My name is Richard Hoeflinger. I am a hunter, having followed that avocation for 60 of my 74 years. I have lived and hunted in Hawaii for the past 15 years, and held leadership positions in many of Hawaii's hunting organizations. As an outdoor writer, I have contributed Hawaii hunting articles to several local and national publications. I am a licensed Hawaii hunting guide and have had the opportunity to interface with numerous visiting mainland hunters.

Hawaii is rich in game resources, and the state's indifference to its economic potential is troubling. Hunting in America is big business. It generates more than \$67 billion in economic output and more than one million jobs. The top 10 states all receive over \$ 1 billion annually in economic benefit from hunting. The top two, Texas and Pennsylvania, receive triple and double that amount, respectively.

Hawaii, Montana, Maine and Idaho are states of similar population. Montana, Maine, and Idaho actively promote hunting in their states, and realize an average of \$430 million in economic benefit annually. Hawaii does nothing to promote its game resources, yet benefits nevertheless from its hunting programs. The estimated overall economic impact from hunting in Hawaii was \$31 million in 1996 and \$28 million in 2001. A modest effort in promotional activities, coupled with a relaxation of counterproductive rules, could increase the state's economic benefit substantially.

Hawaii has a number of statutes and administrative rules that provide no function other than act as an impediment to hunting tourism. Implementation of HCR 174 would serve to identify these problems, whose solution would increase state revenue. I urge you to support the subject resolution.
