The citizens of Northern Uganda have faced atrocities for more than twenty years due to the armed conflict between the Government of Uganda and the Lord's Resistance Army, an armed rebel paramilitary group trying to topple the Ugandan government. The United Nations Under-Secretary-General for Humanitarian Affairs, Jan Egeland, has described the guerilla war in northern Uganda as "the world's greatest neglected humanitarian crisis."

Of the 300,000 child soldiers in the world today, 30,000 of these are in Uganda and they make up 90% of the Lord's Resistance Army. Statistics show that 77% of child abductees have seen someone murdered, 39% have been forced to kill someone with their own hands, and 35% of female soldiers have been sexually abused. Most other children have also been beaten brutally and forced to burn down towns and houses and abduct other children.

Currently an estimated 1.7 million people still remain internally displaced in northern Uganda as a result of the conflict between the government and the Lord's Resistance Army. A growing number of people are being displaced, murdered and abused in the Democratic Republic of Congo as the Lord's Resistance Army terrorizes the area. The effects of the war are seen most prevalently in the lives of the children of these nations. These children face issues of malnutrition, lack of food and water supplies, and other physiological as well as psychological problems from living and fighting in such a long-lasting conflict.

"I support the passage of this resolution and testify that I am against the human rights atrocities and violence presently occurring in Uganda, and Democratic Republic of Congo, by urging Congress to lead the international community in efforts to protect the children of these nations."
