Good Morning. I would like to ask that you support HB35 that asks for April to be recognized as Child Abuse Prevention Month. Not enough is done to address family violence that people tend to incorrectly view as "personal problems" - it's not personal anymore when a child is taken into state custody. Like domestic violence, this is completely avoidable stuff and as long as we're on the topic, more needs to be done about looking at the extremely high correlation between domestic violence and child abuse. The women may be escaping their abusers but the kids get sent back in with him because he's the father of the children. Those children need to be recognized as victims themselves but are often marginalized because even many professionals do not understand how domestic violence turns in to child abuse post separation.
