House Concurrent Resolution 108 and House Resolution 87 urge the State of Hawaii to change the street name of Fort Barrette Road to Kualakai Road.

The Department of Transportation is willing to rename Fort Barrette Road provided the Legislature requests a name change by concurrent resolution and the community supports the proposed new name.

Thank you for allowing me to testify today in support of HCR 108 and HR 87. I am Lance C. Holden, President of 'Ahahui Siwila Hawai'i O Kapölei, the Hawaiian Civic Club of Kapölei. Our club was organized and chartered in 1993 by the Association of Hawaiian Civic Clubs and serves as one of fifty-six component clubs in every county of Hawaii and throughout the continental United States. While each individual club adheres to certain standards upheld by the constitution and by-laws of the umbrella Association, clubs also have individual characteristics.

'Ahahui Kapölei's special interest has been in a garden of native plants that we originated and have supported for more than ten years, and researching the history, identifying and preserving the few remaining historic landmarks of the Ewa Plains. It is through this study that we became aware of the rich culture of this area, and in particular it's historic and pre-historic importance to leeward O'ahu.

This resolution is applicable to some of the objectives of 'Ahahui Kapölei. Promotion and perpetuation of traditional Native Hawaiian values and attitudes. The teaching, learning and use of 'olelo makuahine, the Hawaiian language. Educating the community about the ancient names and historical events that occurred on these islands before the arrival of western influences.

This resolution honors the ancient names and our ancestral connections to the ahupua'a of Honouliuli, O'ahu and all Hawai'i nei.

The history of the first people to inhabit the coasts, plains and mountains of the region has been obscured. Therefore, HCR 108 and HR 87 will serve to enlighten residents of the community that Hawaiians once flourished there.

As the cycles of evolution move Hawaii back to seeking original sources, we fortunately, have been able to authenticate names of the Ewa Plains that even describe the pre-history of the area. Much was lost when the Hawaiian names were discarded to accommodate the new arrivals, but the 'Ahahui believes that the time has come to return to our roots or they will be forever lost.

We ask that you support and pass HCR 108 and HR 87 and should you have any questions, I will certainly be available. Mahalo.

Good morning Chairman Joseph Souki, Madam Vice-Chair and members of the Committee. The Oahu Veterans Council does not support the intent of House Resolution 87. This bill is another attempt to change the historic street names in the former Barbers Point Naval Air Station. Fort Barrette Road was connected to the former Kapolei Military Reservation and until 1934 Fort Barrette was home to cannons protecting the flanks of Pearl Harbor. The site was built up after the December 7, 1941 attack. It was later home to the Army's Nike missiles and abandoned in the late 1950's. The Council is very sensitive to Hawaiian culture. However, Fort Barrette Road is a reminder of Hawaii's military history, and along with its connecting roads, Guadalcanal, Roosevelt, Ranger and Coral Sea should be left alone for future generations to remember the places and events of World War II. Additionally, where would this street renaming end. Other well known transportation routes on Oahu could be identified as old Hawaiian trails as well.

The Oahu Veterans Council is comprised of over 35 Oahu veterans organizations who in turn represent over 80,000 veterans and their families. The council strongly recommends that the Transportation Committee not endorse HR 87. Thank you for this opportunity to testify.

Aloha and Thank You for allowing me to submit testimony opposing HR87.

I am strongly opposed to changing the name of Fort Barrette Road. This would not be Pono.

Fort Barrette and the road are a hugely important part of Ewa-Kapolei history and the road is part of Hawaii's greater significant military history when Oahu was known as the "Gibraltar of the Pacific". That history is actually very astonishing and significant, but too lengthy to go into here.

Fort Barrette Road saw action on December 7, 1941 when the roadway was strafed by Japanese Zeros and Val dive bombers during the attack on Pearl Harbor. This attack on Fort Barrette, and Ewa Field Marine Base, lasted nearly one hour in a series of three waves. This area of Oahu saw more continuous strafing than any other area during the Pearl Harbor raid due to the fact that the Japanese air units used this Ewa area for their staging and re-grouping point.

One Hawaii soldier was killed at Fort Barrette by a strafing plane as soldiers fired back at the Japanese planes. Likely two Japanese planes were shot down in this area, and one was seen in flames flying past Fort Barrette and crashing into the sea near Barbers Point.

Fort Barrette road was built as a supply road for the huge 16 inch gun batteries at Fort Barrette, and the road ran along the railway spur that came off of the OR&L line (which is now on the National Historic Register). This rail line and roadway supported the absolutely colossal engineering feat of hauling many huge 250 ton 16 inch gun barrels and gun carriages up to Fort Barrette in the 1930's. There were two main installed barrels and then also spare barrels as well. Fort Barrette is an engineering and architectural work

of great national historic interest and is very unique. It's recognition and significance is still widely unknown in the modern Kapolei community that has grown up around it.

Fort Barrette road actually continued up into Makalilo Gulch where there are still fortified Army ammunition bunkers once supported by a then existing railway line. The H-1 freeway later cut off this route- the rail is gone but the road still exists as do the military ammunition buildings.

Fort Barrette is in the process of being placed on the National and State Historic Register. There are plans to restore parts of the fort as a museum, which will include Hawaiian Coast Artillery history, National Guard Nike history and ancient Hawaiian Military history, which are all very interesting and significant stories largely unknown to the more modern developed Kapolei community. The planned museum will showcase the entire spectrum of military history- from ancient to modern times, and become a valuable regional resource for the Ewa-Kapolei area and community.

Fort Barrette Road is a very important highway and has very great meaning for many military veterans and civilians who have traveled this roadway, in good times and bad. Recognizing the Hawaiian trail that ran along this same general area is a good project to document and remember, but it doesn't justify renaming Fort Barrette road or altering the honoring and remembrance of Fort Barrette or the other historic road names in the Ewa-Kapolei area that some wish to erase. This particular agenda to erase and rename very historic street and road names is especially disturbing to many in the Ewa-Kapolei community and we will all continue to oppose it in every way we can.

Thank you for allowing me to testify in writing, in support of HCR 108/HR 87. I know that you all have a great deal of urgent matters before you and that the naming of a road is perhaps the least important of them. But this matter is of great importance to those of us who love the history of Hawai'i. It is important to those of us who have watched our place names eradicated by time and circumstance.

Hawaiian place names record the history of the area. It records a history that can provide pride and identity for the children of Hawai'i. Hawaiian place names help the people who live in Hawai'i understand the values of the people who are their neighbors.

The proper name for the road fronting Fort Barrette is Kualaka'i. It honors the chief who brought ulu to our region. The road is directly in front of a concrete structure known as Fort Barrette. The Fort is still named Fort Barrette. The Fort is a concrete bunker built on a Puu known as Puu o Kapolei. The Fort is not going anywhere. It remains...and its name remains...its guns are gone, its purpose is gone, but the Fort remains...as does the name.

The name Kualaka'i is remembered only by the few who know the history of this place...who know the chiefs of the past...there is no acknowledgement of this chief, of his accomplishments, no recognition of our leaders, our history.

It seems to me that there is a fine compromise here. We can acknowledge the host culture by recognizing our leaders...by naming the road fronting Fort Barrette for our Hawaiian leader...and still keep the name of Fort Barrette...for the concrete structure that looms over us all at Puu o Kapolei.

The veterans get to have their history preserved...and we, the native peoples of Hawai'i are able to finally have our history restored.

We urge your support and passage of HCR 108/HR87. Mahalo.

I am strongly opposed House Resolution 87, which will change the name of Fort Barrette Road, at Kapolei. I oppose changing the name of any road.

Fort Barrette Road, like Forts Kamehameha, DeRussy, Ruger, and Fort Weaver were part of the military defense system and history of Oahu.

If non-Hawaiian street names are changed, these street name changes will not cease. People will begin proposing changing other street names as HR87 hints "...much as Farrington Highway was once a foot trail to Waiʻanae..." as reason for changing a street name.
