**Re: Senate Concurrent Resolution 143 and Senate Resolution 95,  
AFFIRMING SUPPORT FOR THE CONCEPT OF ESTABLISHING A BIG ISLAND JUVENILE  
INTAKE AND ASSESSMENT CENTER**

Aloha Chair Chun Oakland, Chair Espero and Committee Members:

Thank you for this opportunity to submit testimony in support of SCR 143 and SR 95, in which the Legislature recognizes the need for a juvenile intake and assessment center to address a longstanding problem in the juvenile justice system in Hawai'i County.

A survey of Big Island police in 2006 found that officers often have no good options when dealing with arrested juveniles who need supervision, but cannot go home, and who do not need secure custody. Existing programs are fragmented, and may not accept youth who are disruptive or are under the influence of alcohol or drugs. The Big Island Juvenile Intake and Assessment Center would help law enforcement by providing a safe holding place for youth so that officers can return to patrol duty.

Beyond assisting police, this program would provide a center where agencies can reach out to at-risk youth, and our young people can get effective help. Police, prosecutors, the Public Defender, the Third Circuit Court and the state Departments of Education, Health and Human Services have all signed agreements to participate in BIJAC as a way of centralizing services.

We are requesting start-up funding for a pilot project in Pahoehoe to provide a single point of entry for intake, assessment and case management of delinquent and at-risk youth. Effectively intervening and providing services to these at-risk youth can keep them from graduating into the adult correctional system, and will save us money in the long run.

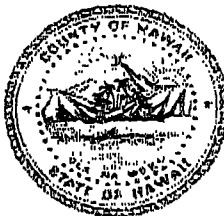

**Testimony in support of SR 95 and SCR 143, Supporting a system of juvenile intake and assessment centers**


As Prosecuting Attorney for the County of Hawaii, I am very pleased to submit this testimony in support of SR 95 and SCR 143.

The idea of establishing one or more centers, where youth in need of safety, supervision, and services can be helped in an integrated and cost-effective way, has been developing since at least 2003. In 2006, with the encouragement of this Legislature (HCR 250, HR 190), my office took on the task of "putting flesh on the bones," and in collaboration with the Judiciary; State Departments of Human Services, Education, and Health; County Police Department; and the Office of the Public Defender, prepared a plan that we believe is both meritorious and practical. However, unfortunately, we find ourselves, as does the rest of Hawaii, in a financial situation that leaves many worthy projects on the drawing board for lack of funding.

SR 95 and SCR 143, if adopted, would give us the recognition that our concepts are on the right track, and that would mean a great deal to us. It is also possible that with this legislative "seal of approval," we would be able to attract new partners, as well as explore funding opportunities that might not otherwise be available to us. It will not be easy, and we will likely be back in future years asking for monetary support, but in the meantime we will do what we can to make progress, since we believe that this concept deserves to move forward.

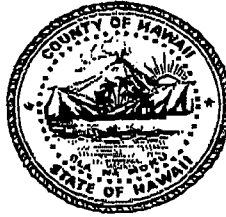

The Office of the Prosecuting Attorney of the County of Hawaii submits this testimony in support of SR 95 and SCR 143, and we thank you both for introducing these measures and for having this hearing.

These resolutions acknowledge the need, and validate the work done to date by the Office of the Prosecuting Attorney and our partners in County and State government as well as the private sector, to establish a single point of entry for intake, assessment, and case management of delinquent and at-risk youth. Such a center would benefit law enforcement, the courts and probation, youth-serving agencies, the general public, and above all, youth and their families.

When the State's financial situation improves, we are hopeful that this concept can be fully funded as appropriate, but we certainly understand that such funding is not possible at the present time.
