## A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that, while there is much  
2 to be proud of in this centennial year of the University of  
3 Hawaii, much more should be done to recognize the many  
4 opportunities and successes of the University of Hawaii. For  
5 example, the people of Hawaii have displayed tremendous support  
6 and loyalty to the University of Hawaii athletics program, which  
7 has been a source of great pride and inspiration for the entire  
8 State, much as professional teams are for other cities and  
9 states. With the significant achievements of the University of  
10 Hawaii Warrior football team, the University of Hawaii must move  
11 forward especially in the areas of facilities renewal, revenue  
12 generation, and compensation.

13           The legislature also finds that leveraging the University  
14 of Hawaii's successes will require focused priorities and  
15 consistent efforts to improve facilities throughout the ten-  
16 campus system. This is an appropriate way to honor the

17 University of Hawaii's first one hundred years, and will allow  
18 the university administration to address much of its facility



1 needs for both academics and athletics. A comprehensive  
 2 approach is needed particularly in the area of athletics to  
 3 ensure that the University of Hawaii is able to secure a  
 4 brighter and more productive second century.

5 The purpose of this Act is to honor the accomplishments of  
 6 the University of Hawaii and make a financial commitment to its  
 7 continued success in the second century since its founding.  
 8 Specifically, this Act provides an environment conducive to  
 9 higher learning for Hawaii's students by authorizing the  
 10 issuance of \$27,949,000 in general obligation bonds for capital  
 11 improvement projects to improve certain UH athletic facilities.

12 SECTION 2. The director of finance is authorized to issue  
 13 general obligation bonds in the sum of \$14,199,000 or so much  
 14 thereof as may be necessary and the same sum or so much thereof  
 15 as may be necessary is appropriated for fiscal year 2009-2010  
 16 for the following capital improvement projects:

17	Ching field, accessibility improvements	\$1,365,000
18	New gymnasium, Klum gym replacement	\$2,584,000
19	Ching field, bleacher replacement	\$ 500,000
20	Les Murakami stadium, renovations	\$2,300,000
21	Stan Sheriff center, renovations	\$ 750,000
22	Gym I and gym II, renovations	\$ 750,000



1	Lower campus road, resurfacing	\$ 350,000
2	Health, physical education, and	
3	recreation classrooms, renovations	\$5,000,000
4	Coaches offices, renovations	\$ 100,000
5	Duke Kahanamoku aquatic center, renovations	\$ 500,000

6 SECTION 3. The director of finance is authorized to issue  
7 general obligation bonds in the sum of \$13,250,000 or so much  
8 thereof as may be necessary and the same sum or so much thereof  
9 as may be necessary is appropriated for fiscal year 2009-2010  
10 for the following capital improvement projects:

11	Women's locker rooms, improvements and	
12	for Title IX compliance	\$3,200,000
13	Men's locker rooms, improvements	\$1,000,000
14	Master plan for lower campus	\$ 750,000
15	Ching field, mauka structure and seats	\$5,000,000
16	Ching field, mauka restrooms and	
17	locker rooms	\$2,300,000
18	Softball stadium, improvements	\$1,000,000

19 SECTION 4. The director of finance is authorized to issue  
20 general obligation bonds in the sum of \$500,000 or so much  
21 thereof as may be necessary and the same sum or so much thereof

2 for the following capital improvement project:

4 Women's soccer and softball  
5 fields, construction \$ 500,000


6 SECTION 5. The appropriations made for the capital  
7 improvement projects authorized in sections 2, 3, and 4 of this  
8 Act shall not lapse at the end of the fiscal year for which the  
9 appropriations are made; provided that all moneys that are  
10 unencumbered as of June 30, 2011, shall lapse as of that date.

11 SECTION 6. The sums appropriated shall be expended by the  
12 University of Hawaii for the purposes of this Act.

13 SECTION 7. This Act shall take effect on July 1, 2009.
