## A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 286-41, Hawaii Revised Statutes, is  
2 amended by amending subsection (b) to read as follows:  
3           "(b) Application for the registration of a vehicle shall  
4 be made upon the appropriate form furnished by the director of  
5 finance and shall contain the name, occupation, and address of  
6 the owner and legal owner; and, if the applicant is a member of  
7 the United States naval or military forces, the applicant shall  
8 give the organization and station. All applications shall also  
9 contain a description of the vehicle, including the name of the  
10 maker, the type of fuel for the use of which it is adapted  
11 (e.g., gasoline, diesel oil, liquefied petroleum gas), the  
12 serial or motor number, and the date first sold by the  
13 manufacturer or dealer, and such further description of the  
14 vehicle as is called for in the form, and such other information  
15 as may be required by the director of finance, to establish  
16 legal ownership. A person applying for initial registration of  
17 a neighborhood electric vehicle shall certify in writing that a  
18 notice of the operational restrictions applying to the vehicle



1 as provided in section 291C-134 are contained on a permanent  
 2 notice attached to or painted on the vehicle in a location that  
 3 is in clear view of the driver. A person applying for the  
 4 registration of a recreational vehicle shall also be required to  
 5 provide evidence of sufficient space to park the recreational  
 6 vehicle on private property. No registration certificate shall  
 7 be issued for a recreational vehicle without this evidence. For  
 8 the purposes of this subsection, "recreational vehicle" means a  
 9 vehicle which is:

- 10 (1) Built on a single chassis;
- 11 (2) Four hundred square feet or less when measured at the  
 12 largest horizontal projection;
- 13 (3) Designed to be self-propelled or permanently towable  
 14 by a light duty truck; and
- 15 (4) Designed primarily not for use as a permanent dwelling  
 16 but as temporary living quarters for recreational,  
 17 camping, travel, or seasonal use."

18 SECTION 2. New statutory material is underscored.  
 19 SECTION 3. This Act shall take effect upon its approval.
