
A BILL FOR AN ACT

RELATING TO MIXED MARTIAL ARTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 440E, Hawaii Revised Statutes, is
2 amended by adding two new sections to be appropriately
3 designated and to read as follows:

4 "§440E- Amateur mixed martial arts. This chapter, with
5 the exception of section 440E-7(a)(2) and (4), shall apply to
6 amateur mixed martial arts contests.

7 §440E- Control and supervision of amateur mixed martial
8 arts contests. Amateur mixed martial arts contests may be
9 placed under the control and supervision of any recognized
10 national amateur mixed martial arts association. The director
11 shall adopt rules pursuant to chapter 91 for the purposes of
12 this section."

13 SECTION 2. Section 440E-1, Hawaii Revised Statutes, is
14 amended by adding a new definition to be appropriately inserted
15 and to read as follows:

16 "Amateur mixed martial arts contestant" means a person who
17 is trained in mixed martial arts and competes in an amateur
18 mixed martial arts contest."



1 SECTION 3. Section 440E-1, Hawaii Revised Statutes, is
2 amended by amending the definition of "mixed martial arts
3 contest" or "contest" to read as follows:

4 "Mixed martial arts contest" or "contest" means a contest
5 or exhibition in a mixed martial arts event in which a mixed
6 martial arts contestant competes with another mixed martial arts
7 contestant, using mixed martial arts, and in which any
8 contestant in the mixed martial arts event receives any money,
9 prize, purse, or other forms of compensation[~~; provided that the~~
10 ~~term does not include an amateur mixed martial arts contest~~]."

11 SECTION 4. Section 440E-5, Hawaii Revised Statutes, is
12 amended by amending subsection (a) to read as follows:

13 "(a) The director is vested with the sole jurisdiction,
14 direction, management, and control over all mixed martial arts
15 contests to be conducted, held, or given within the State[~~;~~
16 ~~provided that this excludes amateur mixed martial arts~~
17 ~~contests~~]. No mixed martial arts contest shall be conducted,
18 held, or given within the State except in accordance with this
19 chapter and the rules adopted by the director pursuant thereto."

20 SECTION 5. Section 440E-8, Hawaii Revised Statutes, is
21 amended by amending subsection (a) to read as follows:

1 "(a) Any person may apply to the director for a license to
2 act as a physician, referee, judge, manager, second, or mixed
3 martial arts contestant to participate, either directly or
4 indirectly, in any mixed martial arts contest. The application
5 shall be in writing, on a form prescribed by the director, and
6 signed by the applicant. The application shall contain a
7 recital of facts as specified by the director for the director
8 to determine whether or not the applicant possesses the
9 necessary licensure and physical, mental, and moral
10 qualifications to entitle the applicant to a license. The
11 license requirement shall not apply to amateur mixed martial
12 arts contestants; provided that an amateur mixed martial arts
13 contestant shall be required to pass a physical examination
14 conducted by a person licensed to practice medicine under
15 chapter 453 prior to engaging in a mixed martial arts contest.
16 The director shall adopt rules for licensure in accordance with
17 chapter 91."

18 SECTION 6. Statutory material to be repealed is bracketed
19 and stricken. New statutory material is underscored.



1 SECTION 7. This Act shall take effect on July 1, 2010.
