
A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a shortage of school
2 supplies for the classroom and funds to purchase the supplies
3 has been an ongoing problem for many years. The legislature
4 believes that to properly address this problem, purchasing power
5 should be concentrated at the classroom level: debit card
6 systems can be implemented so teachers can use the debit cards
7 for specific purchases within a set dollar limit.

8 The benefits of a debit card system include:

- 9 (1) Streamlining the process by which teachers can
10 purchase necessary school supplies and other related
11 curriculum support supplies, thereby eliminating the
12 time lag between the purchase of a product and the
13 reimbursement of out-of-pocket expenses; and
14 (2) Providing teachers with flexibility for their
15 purchases and allowing them to take advantage of
16 school discounts and sales in the community.

17 The legislature further finds that there are banks that can
18 assist with the establishment of debit card system accounts, at



1 little or no cost. A debit card system account can be set up to
2 provide up-to-date spending information.

3 The purpose of this Act is to allow the principal of each
4 public school to establish and use a debit card system based at
5 the individual school level for the purpose of purchasing school
6 supplies and other related curriculum support supplies.

7 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
8 amended by adding a new section to be appropriately designated
9 and to read as follows:

10 "§302A- Purchases of supplies; debit card system. The
11 principal of each public school may establish and use a debit
12 card system to be based at the individual school level for the
13 purpose of purchasing school supplies and other related
14 curriculum support supplies, as deemed appropriate by the
15 school's academic and financial plans."

16 SECTION 3. There is appropriated out of the general
17 revenues of the State of Hawaii the sum of \$ or so much
18 thereof as may be necessary for fiscal year 2009-2010 for the
19 implementation of a debit card system based at the individual
20 school level for the purpose of purchasing school supplies and
21 other related curriculum support supplies.



1 The sum appropriated shall be expended by the department of
2 education for the purposes of this Act.

3 SECTION 4. New statutory material is underscored.

4 SECTION 5. This Act shall take effect on July 1, 2009.
