# HOUSE CONCURRENT RESOLUTION

SUPPORTING H.R. 3680 AND S. 1732 TO AMEND THE PUBLIC HEALTH  
SERVICE ACT TO PROVIDE FOR HEALTH DATA REGARDING NATIVE  
HAWAIIANS AND OTHER PACIFIC ISLANDERS.

1 WHEREAS, Census 2000 identified nearly a million Native  
2 Hawaiians across the nation, with the majority of them living in  
3 Hawaii; and

5 WHEREAS, federal legislation, H.R. 3680, was introduced by  
6 Congresswoman Madeleine Bordallo on September 30, 2009, and was  
7 also sponsored by Congresspersons Neil Abercrombie, Eni  
8 Faleomavaega, Mazie Hirono, Michael Honda, and Gregorio Sablan;

11 WHEREAS, Senator Daniel Inouye also introduced federal  
12 legislation, S. 1732, on September 30, 2009, which was co-  
13 sponsored by Senator Daniel Akaka and was read and referred to  
14 the U.S. Senate Committee on Indian Affairs; and

16 WHEREAS, these bills, both entitled the Native Hawaiian and  
17 Other Pacific Islander Health Data Act of 2009, aim to identify  
18 and evaluate the health status and healthcare needs of Native  
19 Hawaiians and other Pacific Islanders, thereby establishing  
20 baseline health information to achieve equity in health  
21 information for those populations; and

23 WHEREAS, efforts to collect data would be targeted at the  
24 major areas and regions in the continental United States,  
25 Hawaii, American Samoa, the Commonwealth of the Northern Mariana  
26 Islands, the Federated States of Micronesia, Guam, the Republic  
27 of Palau, and the Republic of the Marshall Islands in which  
28 Native Hawaiian and other Pacific Islander people reside; now,  
29 therefore,



1 BE IT RESOLVED by the House of Representatives of the  
2 Twenty-fifth Legislature of the State of Hawaii, Regular Session  
3 of 2010, the Senate concurring, that the Legislature supports  
4 the passage of H.R. 3680 and S. 1732 to amend the Public Health  
5 Service Act to provide for health data regarding Native  
6 Hawaiians and other Pacific Islanders; and

8 BE IT FURTHER RESOLVED that certified copies of this  
9 Concurrent Resolution be transmitted to Hawaii's Congressional  
10 delegation, Congresswoman Madeleine Bordallo, Congressman Eni  
11 Faleomavaega, Congressman Michael Honda, and Congressman  
12 Gregorio Sablan.
