
HOUSE CONCURRENT RESOLUTION

REQUESTING THE ESTABLISHMENT OF KIOSKS IN EACH STATE-OWNED
AIRPORT DEDICATED TO CONSERVATION OUTREACH WITH INFORMATION
ON THE IMPORTANCE OF CARING FOR THE STATE'S UNIQUE AND
FRAGILE ECOSYSTEM.

1 WHEREAS, the Hawaiian monk seal is one of the rarest marine
2 mammals in the world, and among the world's most endangered
3 species, with the population currently declining at four per
4 cent annually and estimated at fewer than one thousand two
5 hundred individuals; and

6
7 WHEREAS, food limitations, entanglements in marine debris,
8 and human interactions including being caught as bycatch in
9 fishing gear, mother-pup disturbance on beaches, and exposure to
10 disease all threaten the remaining population; and

11
12 WHEREAS, in 2008, the Hawaiian monk seal was designated as
13 the State's mammal to increase awareness of it as an endangered
14 species with the hope that this awareness would result in
15 increased protection and its repopulation; and

16
17 WHEREAS, although the main Hawaiian island seals are a
18 small population, they are a much healthier population and are
19 slightly increasing in numbers rather than declining like the
20 larger northern Hawaiian island population; and

21
22 WHEREAS, two recent incidents of intentionally killed monk
23 seals on Kauai and one on Molokai have brought attention to the
24 human threat to the seals; and

25
26 WHEREAS, in September, a Kauai man plead guilty to shooting
27 a seal in violation of the federal Endangered Species Act and
28 received a ninety-day jail term, one year supervised release,
29 and a \$25 fine; and

1 WHEREAS, seal advocates and volunteers worry that such a
2 light sentence sends the wrong message to Hawaii residents and
3 visitors regarding the value of the Hawaiian monk seal; and

5 WHEREAS, a comprehensive outreach program for Hawaii
6 residents and visitors regarding the importance of the Hawaiian
7 monk seal and other endangered Hawaiian flora and fauna needs to
8 be firmly established; and

10 WHEREAS, Hawaii residents and visitors need ready-access to
11 information on the State's unique and fragile ecosystems,
12 recommendations on how to care for the State's ecosystems, and
13 information on how to behave if one comes into contact with an
14 Hawaiian monk seal; now, therefore,

15
16 BE IT RESOLVED by the House of Representatives of the
17 Twenty-fifth Legislature of the State of Hawaii, Regular Session
18 of 2010, the Senate concurring, that the Hawaii Tourism
19 Authority is requested to work in cooperation with the
20 Department of Transportation to establish and maintain kiosks in
21 each State-owned airport dedicated to conservation outreach with
22 information on the importance of caring for the State's unique
23 and fragile ecosystem; and

25 BE IT FURTHER RESOLVED that the Hawaii Tourism Authority is
26 requested to include in each kiosk:

28 (1) Information on the State's unique and fragile
29 ecosystems;

31 (2) Recommendations for visitors and residents on how to
32 care for the State's ecosystems;

34 (3) Information focusing on the Hawaiian monk seal and how
35 to behave if encountered;

37 (4) Both print and video information sources; and

39 (5) Information on applicable federal and state laws with
40 regard to endangered species; and


42 BE IT FURTHER RESOLVED that the Hawaii Tourism Authority is

44 symbol on each kiosk; and
