## HOUSE CONCURRENT RESOLUTION

STRONGLY URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES AND THE CITY OF HONOLULU TO HONOR ACT 15 OF THE 1921 TERRITORIAL LEGISLATURE BY PRESERVING THE WAIKIKI WAR MEMORIAL NATATORIUM IN ITS ORIGINAL LOCATION ON THE WAIKIKI SHORE.

1 WHEREAS, the Twenty-Fifth Legislature finds that in 2 upholding the legislation passed by our forefathers, this body 3 perpetuates the integrity of the Hawaii State Legislature and 4 further ensures that the laws passed today are protected and 5 upheld by those elected to precede this Legislature; and 6

7 WHEREAS, in 1921, the Territorial Legislature of Hawaii 8 passed Act 15 which approved the construction of the Waikiki War 9 Memorial Natatorium, a "Living Memorial" to honor the 102 10 servicemen from Hawaii who were killed during World War I; and 11

WHEREAS, completed in 1927, the Waikiki War Memorial
Natatorium located in close proximity to Diamond Head, across
from Kapiolani Park, and situated between <u>San Souci Beach</u> and
the Waikiki Aquarium; and

WHEREAS, designed by famed architect Louis P. Hobart, the façade features a Beaux-Arts style ornamental arched entryway featuring four stone eagles measuring over twenty feet tall; and 20

21 WHEREAS, the actual Memorial is a 100 by 40-meter tide fed 22 saltwater pool where Buster Crabbe and Johnny Weismuller trained 23 for the 1928 Olympics and has also been host to world-renowned 24 national and international swim competitions, featuring figures 25 such as Duke Kahanamoku, Bill Smith, Ford Konno, coach Soichi 26 Sakamoto and more; and

WHEREAS, although the Waikiki War Memorial Natatorium has
 deteriorated since its initial construction, in 2001, over four

1 million dollars of repairs were completed on the site including a facade restoration and the renovation of the bleachers and 2 3 public restrooms; and 4 5 WHEREAS, the Waikiki War Memorial Natatorium is listed on both the National and Hawaii Registers of Historic Places, is 6 7 not only an architectural anchor for the Waikiki District, but the repository of Hawaii's swimming, ocean sports and Olympic 8 history; and 9 10 11 WHEREAS, in September 2009 The Waikiki Natatorium Task Force announced that by a 9-3 vote its recommendation to the 12 Mayor of the City and County of Honolulu was that the Natatorium 13 14 be demolished; and 15 WHEREAS, in November 2009 City and County of Honolulu Mayor 16 Mufi Hannemann announced that he had accepted The Waikiki 17 Natatorium Task Force's recommendation to demolish the 18 19 Natatorium; and 20 21 WHEREAS, it is in the best interest of this State to 22 preserve Hawaii's uniqueness and cultural identity for the benefit of all its residents as well as its visitors; and 23 24 25 WHEREAS, the National Trust for Historic Preservation has proven that Cultural Heritage Tourists are overall more 26 affluent, stay longer and spend more while contributing to 27 global understanding through cultural exchange and commerce; and 28 29 30 WHEREAS, cultural and heritage visitors spend, on average, \$623 per trip compared to \$457 for all U.S. travelers, excluding 31 the cost of transportation; and 32 33 34 WHEREAS, heritage tourism and more broadly, historic preservation and the efforts of the Heritage Caucus not only 35 36 benefits the State socially but economically as well; now, 37 therefore, 38 BE IT RESOLVED by the House of Representatives of the 39 40 Twenty-fifth Legislature of the State of Hawaii, Regular Session 41 of 2010, the Senate concurring, that the Department of Land and 42 Natural Resources and the City and County of Honolulu honor Act 43 15 of the 1921 Territorial Legislature by preserving the Waikiki
