
A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 302A-501, Hawaii Revised Statutes, is
2 amended by amending the definition of "board" to read as
3 follows:

4 "Board" means the [~~Hawaii teacher standards board.~~] board
5 of education.

6 SECTION 2. Section 302A-602, Hawaii Revised Statutes, is
7 amended by amending subsections (a) and (b) to read as follows:

8 "(a) No person shall serve as a teacher in the department
9 without first having obtained a license from the [~~Hawaii teacher~~
10 ~~standards~~] board in such form as the [~~Hawaii teacher standards~~]
11 board determines. The department shall establish types of
12 certificates in the educational field and the requirements to
13 qualify for those certificates issued to individuals who are not
14 required to obtain a license pursuant to sections [~~302A-801 to~~
15 ~~302A-808.~~] 302A-802 to 302A-807.

16 (b) Beginning with the [~~2002-2003~~] 2009-2010 school year,
17 no person paid under the salary schedule contained in the unit 5
18 collective bargaining agreement shall serve as a teacher in the

1 department without first having obtained a license pursuant to
2 sections [~~302A-801 to 302A-808~~] 302A-802 to 302A-807 from the
3 [~~Hawaii teacher standards~~] board in such form as the [~~Hawaii~~
4 ~~teacher standards~~] board determines."

5 SECTION 3. Section 302A-602.5, Hawaii Revised Statutes, is
6 amended to read as follows:

7 "**§302A-602.5 Certificates; revocation.** The department may
8 revoke any certificate after its issuance if the certificate
9 holder does not possess the requisite qualifications. For the
10 purposes of this section, the term "certificate" does not
11 include a license issued by the [~~Hawaii teacher standards~~] board
12 pursuant to part III, subpart D."

13 SECTION 4. Section 302A-702, Hawaii Revised Statutes, is
14 amended by amending subsection (b) to read as follows:

15 "(b) The [~~Hawaii teacher standards~~] board shall develop,
16 implement, and administer the program."

17 SECTION 5. Chapter 302A, Hawaii Revised Statutes, is
18 amended by amending the title to subpart D of part III to read
19 as follows:

20 "D. Hawaii Teacher Standards [~~Board~~]"

21 SECTION 6. Section 302A-802, Hawaii Revised Statutes, is
22 amended to read as follows:

1 "**§302A-802 Licensing [~~standards,~~] policies.** [~~(a)~~—The
2 board shall establish licensing standards that govern teacher
3 licensing in Hawaii. Licensing standards established by the
4 board shall be adopted as rules under chapter 91 unless
5 otherwise specified in this subpart.

6 ~~(b) In the development of its standards, the board shall
7 consider the existing teacher applicant pool that is available
8 in the State and the level of the qualification of these
9 applicants, as well as the nature and availability of existing
10 preservice higher education teacher training programs.~~

11 ~~(c)~~ The board shall adopt policies, [~~exempt from~~] in
12 accordance with chapters 91 and 92, to initiate the following:

13 (1) Develop criteria allowing more individuals with trade
14 or industry experience to teach in vocational,
15 technical, and career pathway programs, and criteria
16 for the issuance of permits allowing qualified
17 individuals to teach when recommended by the
18 superintendent. The department shall be responsible
19 for the review and acceptance of the relevant
20 licenses, certificates, or other qualifications
21 related to an individual's vocational, technical, or
22 career pathway education-related experience that the

- 1 department deems necessary for a permit. The
2 department shall have the authority to waive the
3 requirement of a bachelor's degree to teach in a
4 vocation, technical, or career pathway education
5 program;
- 6 (2) Develop a plan to accept teachers from any state as
7 long as they have completed state-approved teacher
8 education programs and pass relevant Hawaii teacher
9 examinations or their equivalent;
- 10 (3) Clarify the requirements, on a state-by-state basis,
11 for out-of-state licensed teachers to obtain a license
12 in Hawaii;
- 13 (4) Develop a plan to facilitate licensing for those who
14 intend to teach in Hawaii immersion programs, the
15 island of Niihau, or any other extraordinary situation
16 as defined by the superintendent or the
17 superintendent's designee;
- 18 (5) Pursue full teacher license reciprocity with all other
19 states; and
- 20 (6) Issue a license to a teacher with a valid out-of-state
21 license who has passed similar, though not identical,
22 tests in basic skills, pedagogy, and subject matter to

1 those required for licensure in the State; provided
2 that upon the effective date of the adoption of
3 administrative rules addressing the recognition of
4 out-of-state teacher licenses, those administrative
5 rules shall supersede the requirements of this
6 paragraph."

7 SECTION 7. Section 302A-803, Hawaii Revised Statutes, is
8 amended by amending subsection (a) to read as follows:

9 "(a) In addition to establishing standards for the
10 issuance and renewal of licenses and any other powers and duties
11 authorized by law, the board's powers shall also include:

12 [~~(1)~~] ~~Setting and administering its own budget;~~

13 ~~(2)]~~ (1) Adopting, amending, or repealing the rules of the
14 board in accordance with chapter 91;

15 [~~(3)]~~ (2) Receiving grants or donations from private
16 foundations, and state and federal funds;

17 [~~(4)]~~ (3) Submitting an annual report to the governor and
18 the legislature on the board's operations and from the
19 [~~2007-2008~~] 2009-2010 school year, submitting a
20 summary report every five years of the board's
21 accomplishment of objectives, efforts to improve or

- 1 maintain teacher quality, and efforts to keep its
2 operations responsive and efficient;
- 3 ~~[(+5)]~~ (4) Conducting a cyclical review of standards and
4 suggesting revisions for their improvement;
- 5 ~~[(+6)]~~ (5) Establishing licensing fees in accordance with
6 chapter 91, including the collection of fees by means
7 of mandatory payroll deductions, which shall
8 subsequently be deposited into the state treasury and
9 credited to the Hawaii teacher standards [~~board~~]
10 special fund;
- 11 ~~[(+7)]~~ (6) Establishing penalties in accordance with chapter
12 91;
- 13 ~~[(+8)]~~ (7) Issuing, renewing, revoking, suspending, and
14 reinstating licenses;
- 15 ~~[(+9)]~~ (8) Reviewing reports from the department on
16 individuals hired on an emergency basis;
- 17 ~~[(+10)]~~ (9) Applying licensing standards on a case-by-case
18 basis and conducting licensing evaluations;
- 19 ~~[(+11)]~~ (10) Preparing and disseminating teacher licensing
20 information to schools and operational personnel;
- 21 ~~[(+12)]~~ (11) Approving teacher preparation programs;

1 ~~[(13)]~~ (12) Administering reciprocity agreements with other
2 states relative to licensing;

3 ~~[(14)]~~ (13) Conducting research and development on teacher
4 licensure systems, beginning teacher programs, the
5 assessment of teaching skills, and other related
6 topics;

7 ~~[(15)]~~ (14) Participating in efforts relating to teacher
8 quality issues, conducting professional development
9 related to the board's standards, and promotion of
10 high teacher standards and accomplished teaching; and

11 ~~[(16)]~~ (15) Adopting applicable rules and procedures."

12 SECTION 8. Section 302A-805, Hawaii Revised Statutes, is
13 amended to read as follows:

14 "**§302A-805 Teachers; license required; renewals.** (a)
15 Beginning July 1, ~~[2002,]~~ 2010, all new and renewal licenses
16 shall be issued by the board. No person shall serve as a half-
17 time or full-time teacher in a public school without first
18 having obtained a license from the board under this subpart.
19 All licenses issued by the board shall be valid only for the
20 fields specified on the licenses and shall be renewable every
21 five years if the individual continues to:

22 (1) Satisfy the board's licensing standards;

1 (2) Show evidence of successful teaching in the previous
2 five years; and

3 (3) Satisfy the board's requirements for renewal of
4 licenses.

5 (b) Teachers whose licenses expire on June 30, 2002, or
6 June 30, 2003, shall be granted an automatic extension of [~~two~~]
7 seven years.

8 (c) No person shall be issued a license or teach on an
9 emergency basis in the public schools without having first paid
10 the fees established by the board in accordance with chapter 91.

11 (d) Teachers whose licenses expire on or after July 1,
12 2009, but before July 1, 2010, shall be granted an automatic
13 extension of one year in which to obtain a renewal of their
14 licenses. The board, at its discretion, may grant an additional
15 one year extension of these licenses."

16 SECTION 9. Section 302A-806, Hawaii Revised Statutes, is
17 amended to read as follows:

18 **"§302A-806 Hawaii teacher standards [~~board~~] special fund.**

19 There is established within the state treasury a special fund to
20 be known as the Hawaii teacher standards [~~board~~] special fund,
21 into which shall be deposited all moneys received by the board
22 in the form of appropriations, fees, fines, grants, donations,

1 or revenues regardless of their source. The special fund shall
2 be administered by the department and used to pay the expenses
3 of the board, including but not limited to the payment of all
4 operational and personnel costs, and reimbursements to board
5 members for travel expenses incurred."

6 SECTION 10. Section 302B-10, Hawaii Revised Statutes, is
7 amended by amending subsection (d) to read as follows:

8 "(d) The department, in conjunction with the office, shall
9 facilitate and encourage the movement of instructional personnel
10 between the department and charter schools; provided that:

11 (1) Comparable and verifiable professional development and
12 employee evaluation standards and practices, as
13 determined and certified by the office, are in place
14 in charter schools for instructional staff;

15 (2) Licensed charter school teachers, as determined by the
16 [~~Hawaii teacher standards~~] board, who are not yet
17 tenured in the department and are entering or
18 returning to the department after full-time employment
19 of no less than one full school year at a charter
20 school, shall be subject to no more than one year of
21 probationary status; and

1 (3) Tenured department licensed teachers, as determined by
2 the department, who transfer to charter schools shall
3 not be required to serve a probationary period."

4 SECTION 11. Section 304A-701, Hawaii Revised Statutes, is
5 amended by amending subsection (a) to read as follows:

6 "(a) There is created the Hawaii educator loan program to
7 be administered by the University of Hawaii, in partnership with
8 a financial institution whose operations are principally
9 conducted in Hawaii, to provide financial support to students
10 and teachers who complete a state-approved teacher education
11 program and who agree to teach as a full-time teacher for a
12 period of time to be determined by the university prior to the
13 award of a loan, in:

14 (1) The Hawaii public school system in a hard-to-fill
15 position including special education, regular
16 education shortage categories, or Title 1 schools, and
17 in one of the following capacities:

18 (A) As an elementary school teacher teaching in the
19 field of elementary education who has met
20 standards as set forth by the [~~Hawaii teacher~~
21 ~~standards board;~~] board of education; or

1 (B) As a secondary school teacher teaching in the
2 subject area that is relevant to the loan
3 recipient's academic major as certified by the
4 department of education who has met standards as
5 set forth by the [~~Hawaii teacher standards~~
6 ~~board;~~] board of education; or

7 (2) At a school located in a rural area in the State, as
8 determined by the superintendent of education.

9 Eligibility shall be determined by the university on a
10 competitive basis. The amount to be loaned to a student shall
11 be determined by the board of regents based on need for
12 financial aid and proof of acceptance into a state-approved
13 teacher education program at the university. The maximum amount
14 of loans that a student may receive under this program shall be
15 an aggregate amount equivalent to tuition payments and costs of
16 textbooks and other instructional materials necessary to
17 complete a state-approved teacher education program."

18 SECTION 12. Section 304A-1201, Hawaii Revised Statutes, is
19 amended to read as follows:

20 "~~[+]§304A-1201[+]~~ **College of education.** The college of
21 education shall be affiliated with the university and shall be
22 under the jurisdiction and management of the board of regents.

1 The board may grant appropriate degrees to properly qualified
2 graduates of the college of education. In establishing the
3 curriculum for the college of education, the university
4 authorities may obtain the approval of the [~~Hawaii teacher~~
5 ~~standards~~] board[~~-~~] of education. The mission of the college of
6 education is to:

- 7 (1) Prepare and provide ongoing professional development
8 of teachers, administrators, counselors, and related
9 professionals at undergraduate and graduate levels
10 primarily to meet the needs of Hawaii schools;
- 11 (2) Generate, synthesize, and apply knowledge in education
12 and related fields through teaching, research, and
13 other scholarly activities; and
- 14 (3) Provide service and support to the local, national,
15 and global educational and related communities."

16 SECTION 13. Section 304A-1202, Hawaii Revised Statutes, is
17 amended by amending subsection (a) to read as follows:

18 "(a) There is created an advisory committee to be known as
19 the teacher education coordinating committee to identify, study,
20 take action, or make recommendations on matters of education of
21 common interest to the department of education and institutions
22 of higher learning in Hawaii. The membership of the committee

1 shall include the superintendent of education and the dean of
2 the college of education of the University of Hawaii, who shall
3 serve in alternate years as chairperson of the committee with
4 the superintendent acting as the first chairperson, a
5 representative from each accredited teacher training institution
6 in Hawaii, and a representative from the [~~Hawaii teacher~~
7 ~~standards board.~~] board of education. In addition, the
8 superintendent of education and the dean of the college of
9 education may each appoint other members to the committee;
10 provided that the dean of the college of education shall appoint
11 at least two members of the committee from the university who
12 are not within the college of education."

13 SECTION 14. Section 315-2, Hawaii Revised Statutes, is
14 amended to read as follows:

15 "**§315-2 Official for State.** The "designated State
16 Official" for Hawaii shall be the [~~executive director of the~~
17 ~~Hawaii teacher standards board.~~] superintendent of education."

18 SECTION 15. Section 302A-603, Hawaii Revised Statutes, is
19 repealed.

20 [~~"§302A-603 Teaching without certificates or licenses;~~
21 ~~penalty.~~ (a) ~~Except as otherwise provided, before the 1997-~~
22 ~~1998 school year, whoever serves in the department as a teacher~~

1 ~~without holding an unrevoked certificate issued under sections~~
2 ~~302A-602 to 302A-640, and 302A-701, shall be fined not more than~~
3 ~~\$25.~~

4 ~~(b) Beginning with the 1997-1998 school year, whoever~~
5 ~~serves in the department as a teacher, paid under the salary~~
6 ~~schedule contained in the unit 5 collective bargaining~~
7 ~~agreement, without holding an unrevoked or unsuspended license~~
8 ~~or credential issued under sections 302A-801 to 302A-808, shall~~

15 ~~(d) Beginning with the 2002-2003 school year, emergency~~
16 ~~hires shall not be subject to this penalty."]~~

17 SECTION 16. Section 302A-801, Hawaii Revised Statutes, is
18 repealed.

19 [~~"§302A-801 Hawaii teacher standards board established.~~

20 ~~(a) There is established the Hawaii teacher standards board,~~
21 ~~which shall be placed within the department for administrative~~
22 ~~purposes only. The board shall consist of thirteen members,~~

1 ~~including not less than six licensed teachers regularly engaged~~
2 ~~in teaching, three educational officers, the chairperson of the~~
3 ~~board of education or the chairperson's designee, the~~
4 ~~superintendent or the superintendent's designee, a~~
5 ~~representative of independent schools, and the dean of the~~
6 ~~University of Hawaii college of education or the dean's~~
7 ~~designee; provided that the dean's designee shall be chosen from~~
8 ~~the member institutions of the teacher education coordinating~~

14 SECTION 17. Section 302A-805.6, Hawaii Revised Statutes,
15 is repealed.

16 ~~["§302A-805.6]—Efforts related to teacher quality.—(a)~~
17 ~~The board may participate in efforts relating to issues~~
18 ~~affecting teacher quality. The board may conduct professional~~
19 ~~development activities related to its standards, and shall~~
20 ~~promote and support high teacher standards and accomplished~~
21 ~~teaching through means deemed appropriate by the board.~~

1 ~~(b) To remain current with trends and issues in teacher~~
2 ~~licensure systems, beginning teacher programs, the assessment of~~
3 ~~teaching skills, teacher development, and other related topics,~~
4 ~~the board shall participate in programs and attend conferences~~
5 ~~and training that address these topics. The board may conduct~~
6 ~~research and development activities for the purpose of staying~~
7 ~~abreast of or better understanding these trends and issues."]~~

8 SECTION 18. Section 302A-808, Hawaii Revised Statutes, is
9 repealed.

10 ~~["**S302A-808 Penalty.** Any person who engages in the~~
11 ~~profession of teaching in a public school without first being~~
12 ~~issued a license or hired on an emergency basis as defined in~~
13 ~~this chapter shall be fined not more than \$500. Any person who~~
14 ~~knowingly or intentionally violates this subpart by employing an~~
15 ~~individual as a public school teacher who does not possess a~~
16 ~~valid license or is not a department of education emergency hire~~
17 ~~as defined in this chapter may be fined not more than \$500. All~~
18 ~~finer shall be deposited into the Hawaii teacher standards board~~
19 ~~special fund."]~~

20 SECTION 19. All rights, powers, functions, and duties of
21 the Hawaii teacher standards board are transferred to the board
22 of education.

1 All officers and employees whose functions are transferred
2 by this Act shall be transferred with their functions and shall
3 continue to perform their regular duties upon their transfer,
4 subject to the state personnel laws and this Act.

5 No officer or employee of the State having tenure shall
6 suffer any loss of salary, seniority, prior service credit,
7 vacation, sick leave, or other employee benefit or privilege as
8 a consequence of this Act, and such officer or employee may be
9 transferred or appointed to a civil service position without the
10 necessity of examination; provided that the officer or employee
11 possesses the minimum qualifications for the position to which
12 transferred or appointed; and provided that subsequent changes
13 in status may be made pursuant to applicable civil service and
14 compensation laws.

15 An officer or employee of the State who does not have
16 tenure and who may be transferred or appointed to a civil
17 service position as a consequence of this Act shall become a
18 civil service employee without the loss of salary, seniority,
19 prior service credit, vacation, sick leave, or other employee
20 benefits or privileges and without the necessity of examination;
21 provided that such officer or employee possesses the minimum

1 qualifications for the position to which transferred or
2 appointed.

3 If an office or position held by an officer or employee
4 having tenure is abolished, the officer or employee shall not
5 thereby be separated from public employment, but shall remain in
6 the employment of the State with the same pay and classification
7 and shall be transferred to some other office or position for
8 which the officer or employee is eligible under the personnel
9 laws of the State as determined by the head of the department or
10 the governor.

11 SECTION 20. All appropriations, records, equipment,
12 machines, files, supplies, contracts, books, papers, documents,
13 maps, and other personal property heretofore made, used,
14 acquired, or held by the Hawaii teacher standards board relating
15 to the functions transferred to the board of education shall be
16 transferred with the functions to which they relate.

17 SECTION 21. All rules, policies, procedures, guidelines,
18 and other material adopted or developed by the Hawaii teacher
19 standards board to implement provisions of the Hawaii Revised
20 Statutes which are reenacted or made applicable to the board of
21 education by this Act, shall remain in full force and effect
22 until amended or repealed by the board of education pursuant to

1 chapter 91, Hawaii Revised Statutes. In the interim, every
2 reference to the Hawaii teacher standards board or the
3 chairperson of the Hawaii teacher standards board in those
4 rules, policies, procedures, guidelines, and other material is
5 amended to refer to the board of education or chairperson of the
6 board of education as appropriate.

7 SECTION 22. Statutory material to be repealed is bracketed
8 and stricken. New statutory material is underscored.

9 SECTION 23. This Act shall take effect on June 30, 2040,
10 provided that the amendment made under section 7 of this Act
11 shall not be repealed when section 302A-803, Hawaii Revised
12 Statutes, is repealed on July 1, 2009, and reenacted in the form
13 in which it read on June 30, 2007, by Act 263, Session Laws of
14 Hawaii 2007.

Transfers functions and duties of the Hawaii teacher standards board to the board of education. (SD1)
