
SENATE CONCURRENT RESOLUTION

CONVENING A WORKING GROUP TO EXAMINE FARM TO SCHOOL MODELS.

1 WHEREAS, the farm to school program connects schools with
2 local farms with the objectives of supporting local agriculture,
3 educating students about food cultivation, mitigating adverse
4 environmental impacts caused by transporting food across long
5 distances, and instilling healthy eating habits in students; and
6

7 WHEREAS, the farm to school program contains two major
8 components: first, students receive education on nutrition, and
9 are taught the value of buying and eating local food, and
10 second, local food is served in school cafeterias, giving
11 students the choice to eat healthier and fresher produce; and
12

13 WHEREAS, the National Farm to School Program reports that
14 some form of the farm to school program is currently operating
15 in 8,776 schools in forty different states; and
16

17 WHEREAS, several Hawaii schools participate in alternative
18 farm to school programs, including:
19

20 (1) 'AINA IS: Actively Integrating Nutrition & Agriculture
21 in Schools is a farm to school program currently in
22 ten Oahu elementary schools: Aikahi, Waialae,
23 Wheeler, Makaha, Ahuimanu, Samuel M. Kamakau charter
24 school, Waikiki, Ala Wai, Sunset Beach, and Waialua;
25

26 (2) Moanalua Elementary School and Moanalua Intermediate
27 and High School, which feed their students by using
28 local foods and a school garden, which is incorporated
29 as part of their learning;
30

31 (3) MA'O Organic Farms is an organic farm located in
32 Waianae, Oahu, with two farm to school projects in
33 Waianae Intermediate and High School, including a



1 half-acre on-campus organic garden - the first Hawaii
2 public school to have a certified organic garden; and
3

- 4 (4) The Kohala Center, through its Hawai'i Island School
5 Garden Network, works with over forty-five public,
6 charter, and private schools on Hawaii island to help
7 island schools build gardening and agricultural
8 programs that will significantly contribute to the
9 increased consumption of locally produced foods; and
10

11 WHEREAS, these schools and programs can serve as models for
12 an expansion of the farm to school program in public schools
13 statewide; now, therefore,
14

15 BE IT RESOLVED by the Senate of the Twenty-fifth
16 Legislature of the State of Hawaii, Regular Session of 2010, the
17 House of Representatives concurring, that the Senate Committees
18 on Economic Development and Technology; Education and Housing;
19 Higher Education; and Water, Land, Agriculture and Hawaiian
20 Affairs, and the House Committees on Economic Revitalization,
21 Business and Military Affairs; Education; Higher Education; and
22 Agriculture convene a working group to examine farm to school
23 models; and

25 BE IT FURTHER RESOLVED that in addition to members of the
26 above legislative committees, the working group include
27 representatives from the:
28

- 29 (1) University of Hawai'i College of Tropical Agriculture
30 and Human Resources;

32 (2) Department of Agriculture;

34 (3) Department of Education;

36 (4) Hawaii Association of Independent Schools;

38 (5) Hawai'i Nutrition and Physical Activity Coalition

14 BE IT FURTHER RESOLVED that the working group members be
15 appointed by the President of the Senate and the Speaker of the
16 House of Representatives; and
17

18 BE IT FURTHER RESOLVED that the examination include local
19 models such as 'AINA IS: Actively Integrating Nutrition &
20 Agriculture in Schools, Moanalua Elementary School, MA'O Organic
21 Farms, and The Kohala Center, as well as national programs such
22 as the Summer Food Service Program, Child and Adult Care Food
23 Program, School Breakfast Program, and Afternoon Snack Program;
24 and
25

26 BE IT FURTHER RESOLVED that the working group propose a
27 pilot farm to school program for each island, to include, at
28 minimum:
29

- 30 (1) Concepts of local, fresh food production, safety,
31 supply, and procurement;

33 (2) Infrastructure development;
34
35 (3) Financing, including federal and private sector
36 funding sources;

38 (4) Health and nutrition education;

40 (5) Family and community outreach and involvement; and

42 (6) The means to address barriers and challenges to
43 implementation of a farm to school program, including



1 government procurement requirements and training
2 programs for farms; and
3

4 BE IT FURTHER RESOLVED that the working group report its
5 findings and recommendations, including a pilot farm to school
6 program for each island to the Legislature no later than twenty
7 days prior to the convening of the Regular Session of 2011; and
8

9 BE IT FURTHER RESOLVED that certified copies of this
10 Concurrent Resolution be transmitted to the President of the
11 Senate, the Speaker of the House of Representatives, the
12 Superintendent of Education, Chair of the Board of Education,
13 Chair of the Board of Agriculture, Dean of the University of
14 Hawai'i College of Tropical Agriculture and Human Resources,
15 Hawaii Association of Independent Schools, Hawai'i Nutrition and
16 Physical Activity Coalition, Hawaii Farm Bureau Federation,
17 Hawaii Farmers Union, Kokua Hawai'i Foundation, AINA In Schools
18 Program, MA'O Organic Farms, The Kohala Center, Malama Kaua'i,
19 Sustainable Living Institute on Maui, and Slow Food Oahu.
