Dear Madam President:

Transmitted herewith are proposed changes to the Appropriations Act (House Bill No. 2200). Your favorable consideration is requested for the attached budget items:

Operating:

Department of Accounting and General Services:

1. Increase the Office of Elections (AGS 879) general fund appropriation by \$250,000 in FY 10 to support the 2010 regular elections. The funds will be used to: purchase Election Day logistical supplies, ballot transport and delivery services; print poll books; fund travel for training and site inspections; fund Election Commission travel for hearings; and purchase postage for election materials and software licenses.
2. Increase the Office of Elections (AGS 879) general fund appropriation by \$140,000 in FY 10 to reimburse the City and County of Honolulu for expenditures resulting from conducting a special election due to the resignation of U.S. Representative Neil Abercrombie.

Department of the Attorney General:

Correct a general fund reduction in Legal Services (ATG 100) in FY 11 relating to reimbursement from the Department of Commerce and Consumer Affairs (DCCA) for legal services. General funds in Legal Services were reduced by \$360,000 assuming that the entire amount would be reimbursed by DCCA. However, a memorandum of agreement establishes a cap of \$200,000 for reimbursement. The adjustments will: increase \$160,000

in general funds to correct initial reduction of \$360,000 to \$200,000 and increase the interdepartmental fund by \$200,000; adds \$160,000 in non-general funds and fringe (total \$214,600); and deletes \$160,000 in general funds in personal services.

Department of Human Services:

Increase the general fund appropriation in FY 11 for Health Care Payments (HMS 401) by \$64,000,000 to address the FY 09 carryover shortfall in the Medicaid payments program.

Department of Land and Natural Resources:

Restore 1.00 permanent federal fund position count in LNR 401 (Aquatic Resources) and abolish 1.00 temporary federal fund position in LNR 401 (Aquatic Resources). As part of the executive budget, the Department of Land and Natural Resources (DLNR) identified a temporary Northwestern Hawaiian Islands Policy Specialist position to be abolished; however, DLNR erroneously listed the position as a permanent count.

Department of Taxation:

1. Restore 15.00 temporary general fund position counts in the Tax Services and Processing program (TAX 105) which were inadvertently deleted twice. No additional funds are required.
2. Adjust and reallocate the general fund amounts for furlough savings for TAX's three program IDs. The adjustments will be budget neutral and will correct minor errors in the department's original budget submittal. The overall furlough savings for the department will remain at -\$1,754,264.
  - Reduce the general fund appropriation for TAX (TAX 100) by -\$46,420 to adjust the furlough savings from -\$817,500 to -\$863,920.
  - Increase the general fund appropriation for Tax Services and Processing (TAX 105) by \$57,260 to adjust the furlough savings from -\$532,932 to -\$475,672.
  - Reduce the general fund appropriation for Supporting Services - Revenue Collection (TAX 107) by -\$10,840 to adjust the furlough savings from -\$403,832 to -\$414,672.

Capital Improvement Program:

Department of Accounting and General Services:

New request to increase the special funds by \$2,000,000 in FY 11 for a CIP project to upgrade the Aloha Stadium sub-surface drainage system and replace the synthetic field covering system (field turf). The six-year old field turf has significant deterioration from

multiple splitting and compaction of sand infill, which results in a harder playing surface causing injury to players. The sub-surface drainage system does not remove surface water flows in a timely manner. The construction project will include: the removal of the field turf; repaving the underlying asphalt layer; and installing new field turf.

Department of Hawaiian Home Lands:

New request to increase the general obligation bond funds by \$2,500,000 in FY 11 to provide the engineering services needed to design repair/improvements or abandonment of five dams in Kauai. Built over 80 years ago, the dams provided irrigation water for the sugarcane plantations on Kauai. The engineering services will include the assessment of the dam conditions and recommendations for appropriate actions necessary to maintain the safety of people or property affected by the dams.

Department of Transportation:

Airports Division:

1. New request to increase the other funds (Customer Facility Charges fund) by \$68,800,000; \$6,200,000 in FY 10 and \$62,600,000 in FY 11 to consolidate car rental facilities for the rental car agencies at statewide airports (TRN 195), which would decrease potential injury to employees and damage to vehicles, and generate lease income to the Airports Division.
2. New request to increase revenue bonds by \$30,000,000 in FY 11 to construct infrastructure for future energy savings at statewide airports (TRN 195) to reduce energy consumption and related costs.

Harbors Division:

1. New request to increase revenue bonds by \$8,200,000 in FY 11 for land acquisition for the development of a new container terminal facility and other related improvements at the Kapalama Container Terminal Facility, Honolulu Harbor, Oahu (TRN 301).
2. New request to increase revenue bonds by \$25,150,000 in FY 11 for land acquisition and planning for Kalaeloa Barbers Point Harbor improvements, Oahu (TRN 303).

Highways Division:

1. New request to increase revenue bonds by \$3,650,000 in FY 11 for land acquisition and construction of drainage improvements along Farrington Highway in the Vicinity of Orange Street Intersection, Makaha, Oahu (TRN 501).

2. New request to increase revenue bonds by \$3,440,000 and federal funds by \$13,760,000 in FY 11 for land acquisition and construction for rehabilitation of Umauma Stream Bridge on the Hawaii Belt Road, Hawaii (TRN 511).
