
A BILL FOR AN ACT

RELATING TO DEATH BENEFITS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 346-15, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "§346-15 ~~[Burial of]~~ Death benefits for deceased medical
4 or financial assistance recipients [or] and disposition of
5 unclaimed corpses. (a) [The] Where the decedent was a medical
6 or financial assistance recipient at the time of death and is
7 ineligible for the Social Security Lump-Sum Death Benefit, the
8 department of human services may [bear the cost of the burial of
9 deceased medical or financial assistance recipients or unclaimed
10 corpses. Burial services include the customary mortuary,
11 crematory, cemetery, and other services essential in providing a
12 dignified burial.] issue a lump-sum death benefit in an amount
13 equal to the Social Security Administration's Lump-Sum Death
14 Benefit for that year.

15 (b) ~~[The department may pay for mortuary and crematory~~
16 ~~services to be furnished by any licensed provider of mortuary~~
17 ~~and crematory services. Mortuary and crematory payments shall~~
18 ~~be made to the extent of cost, or in the sum of \$400, whichever~~



1 ~~is less.]~~ The department may authorize and bear the cost of the
2 mortuary and crematory services for unclaimed corpses furnished
3 by any licensed provider of mortuary or crematory services.

4 Payments for mortuary and crematory services shall be made to
5 the extent of cost, or in the sum of \$800 in total, whichever is
6 less, for each unclaimed corpse.

7 ~~[(c) The department may pay for cemetery services, to be~~
8 ~~furnished by any licensed provider of cemetery services.~~

9 ~~Cemetery payments shall be made to the extent of cost, or in the~~
10 ~~sum of \$400, whichever is less.~~

11 ~~(d) In cases where the decedent is survived by relatives,~~
12 ~~the relatives shall be permitted to make their own arrangements~~
13 ~~for the burial or cremation of their deceased relative.~~

14 ~~(e) The person submitting an application for funeral~~
15 ~~payments under the department's funeral payment program,]~~

16 (c) Any person submitting an application for the lump-sum
17 death benefit described in subsection (a) on behalf of a
18 deceased medical or financial assistance recipient, shall have
19 sixty days from the date of the death of the deceased to submit
20 the application [for funeral payments] to the department. [This
21 subsection shall not apply to applications submitted by the

3 ~~(f) All unclaimed corpses shall be cremated. The~~
4 ~~department of human services shall authorize the cremation of~~
5 ~~unclaimed corpses.~~

6 ~~(g)]~~ (d) A person or public or private agency, including
7 the department of human services, shall not be liable for any
8 damage or subject to criminal prosecution for any act done
9 pursuant to and in compliance with this section.

10 ~~[(h)]~~ (e) For ~~[the]~~ purposes of this section, "unclaimed
11 corpse" means the remains of any deceased person for whom no one
12 has assumed responsibility for disposition of the body within
13 five working days, excluding weekends, from the date of death
14 and about whom the department and the respective county medical
15 examiner or coroner have no actual knowledge of a legally
16 responsible party.

17 ~~[(i)]~~ (f) The department shall adopt rules pursuant to
18 chapter 91 for purposes of administering and implementing this
19 section."
