# A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums or so much  
5 thereof as may be necessary to fund for fiscal biennium  
6 2009-2011 all collective bargaining cost items in the agreement  
7 negotiated with the exclusive bargaining representative of  
8 collective bargaining unit 6:

 20 paid, in whole or in part, from federal, special, or other funds  
 21 shall be paid wholly or proportionately, as the case may be,  
 22 from the respective funds.



1 SECTION 8. Funds appropriated or authorized by this Act  
2 that are not expended or encumbered by June 30, 2010, and  
3 June 30, 2011, of the respective fiscal years, shall lapse as of  
4 those dates.

5 SECTION 9. This Act shall take effect on July 1, 2009.
