A BILL FOR AN ACT

AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS AND MAKING AN APPROPRIATION FOR 'ALIOMANU ROAD RECONSTRUCTION AND PROTECTION, KAPA'A NEW PARK (STADIUM) IMPROVEMENTS, OPEN SPACE/PARK LAND ACQUISITION, AND KILAUEA AGRICULTURAL PARK DEVELOPMENT FOR THE COUNTY OF KAUA'I.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$7,300,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2010-2011
5 for the following projects for the county of Kauai:

6 1. 'Aliomanu Road Reconstruction and Protection \$1,500,000

7 The earthen makai edge of 'Aliomanu road has
8 experienced significant erosion over the years
9 due to ocean wave action. The erosion has
10 reached a critical distance from the edge of
11 pavement and warrants urgent corrective measures
12 to insure that this important county asset is not
13 jeopardized. This project will provide for the
14 construction of a five hundred foot revetment to
15 protect a portion of 'Aliomanu road. The roadway
16 will also be reconstructed to its originally



1 installed condition. The total estimated cost of
2 the project is \$3,000,000.

3 2. Kapa'a New Park (Stadium) Improvements \$ 500,000

4 The Kawaihau district of Kaua'i is the most
5 populous area of the island, yet it has never had
6 a sports facility with all the necessary
7 infrastructure to support large scale
8 recreational activities. The county of Kaua'i,
9 in collaboration with the community, the
10 department of education, and Kapa'a high school,
11 have implemented a systematic development plan
12 for the Kapa'a new park facility. The
13 construction of locker room facilities is the
14 final component of this collaborative plan to
15 bring major sports activities to this complex
16 which services communities from Wailua to
17 Hanalei. The estimated construction costs are
18 \$1,000,000.

19 3. Open Space/Park Land Acquisition \$4,000,000

20 The preservation of open space, access to inland
21 and coastal areas, and the expansion of park
22 areas are of great importance to the Kaua'i



1 community. The county of Kaua'i is seeking to
2 collaborate with the federal government, the
3 State, the Kaua'i Public Land Trust, and others
4 in acquiring lands to support greater public
5 access and areas for increased recreational use.
6 As the public's interest in outdoor activities
7 increase, the demand on existing park lands also
8 increases. The expansion of areas including the
9 Black Pot Beach Park in Hanalei, and the Salt
10 Pond Beach Park in Hanapēpē are of great interest
11 to the island community. In addition, the county
12 of Kaua'i is seeking to acquire and improve
13 access to public areas such as Kauapea Beach in
14 Kīlauea and Pāpa'a Bay situated between 'Aliomanu
15 and Moloa'a on the island's northeastern shore.
16 The county is proposing to make a significant
17 investment to move that initiative forward.
18 Thus, \$8,000,000 is being identified as initial
19 funding for this effort.

20 4. Kilauea Agricultural Park Development \$1,300,000

21 The proposed Kilauea agricultural park is
22 situated on a seventy-five acre parcel that was



1 transferred to the county of Kaua'i in 2006. The
2 park will provide nine farm lots, approximately
3 five acres each, an orchard, an energy farm, a
4 community garden, a farmer's market and four
5 incubator farm lots. The county's desire is to
6 design and develop a project that will provide
7 for the grading and graveling of roads;
8 construction of a well; installation of
9 waterlines; construction of a reservoir; grading
10 for the energy farm, composting area, and
11 farmer's market; installation of an exterior
12 windbreak; and the installation of necessary
13 internal fencing. The estimated unfunded
14 development cost for this project is \$2,600,000.

15 The estimated project total is \$4,000,000.

16 SECTION 2. The appropriation made for the capital
17 improvement projects authorized by this Act shall not lapse at
18 the end of the fiscal biennium for which the appropriation is
19 made; provided that all moneys from the appropriation
20 unencumbered as of June 30, 2012, shall lapse as of that date.

21 SECTION 3. The sums appropriated shall be expended by the
22 county of Kauai for the purposes of this Act.


