# SENATE CONCURRENT RESOLUTION

URGING THE BOARD OF NATUROPATHIC MEDICINE TO ADOPT RULES  
CONSISTENT WITH ACT 22, SPECIAL SESSION LAWS OF HAWAII  
2009, TO ALLOW NATUROPATHIC PHYSICIANS TO PERFORM  
PARENTERAL THERAPY.

1           WHEREAS, naturopathic doctors licensed in Hawaii and  
2 nationwide have been administering natural substances including  
3 vitamins, minerals, and amino acids subcutaneously,  
4 intramuscularly, and intravenously (parenterally) for over  
5 twenty years; and

6  
7           WHEREAS, the Board of Naturopathic Medicine issued an  
8 opinion in 1984 that the injection of vitamins was within the  
9 scope of practice of naturopathic physicians; and

10  
11           WHEREAS, licensing laws exist to ensure a minimal level of  
12 competency in the practice of naturopathic medicine; and

13  
14           WHEREAS, the licensing examinations accepted by the State  
15 of Hawaii have included and covered parenteral therapeutics; and

16  
17           WHEREAS, all accredited professional schools of  
18 naturopathic medicine educate, train, and qualify students to  
19 perform parenteral therapeutics including intramuscular,  
20 subcutaneous, and intravenous injection techniques and skills;  
21 and

22  
23           WHEREAS, in addition to education, training, and  
24 examination, error-free and complaint-free performance  
25 demonstrates professional competency among naturopathic  
26 physicians of parenteral therapy; and

27  
28           WHEREAS, for example, insurance companies issuing  
29 naturopathic malpractice insurance cover practitioners using  
30 parenteral techniques, and the largest malpractice insurance  
31 companies have not received one malpractice claim throughout the



1 nation against a naturopathic physician for the misuse of  
2 injection methods; and  
3

4 WHEREAS, in addition, there has not been one case of misuse  
5 or harm caused by parenteral therapy reported to the Hawaii  
6 Board of Naturopathic Medicine or the Hawaii Society of  
7 Naturopathic Physicians; and  
8

9 WHEREAS, in 2006, the Legislature approved H.B. No. 1155 to  
10 clarify that naturopathic physicians have the authority to  
11 administer natural medicines by injection but the bill was  
12 vetoed by the Governor; and  
13

14 WHEREAS, the Legislature, through Act 22, Special Session  
15 Laws of Hawaii 2009, directed the Board of Naturopathic Medicine  
16 to "establish the education and training requirements for  
17 parenteral therapy and the standards to administer parenteral  
18 therapy" for licensed naturopathic physicians; and  
19

20 WHEREAS, the Legislature also directed the Board of  
21 Naturopathic Medicine to "[a]nnually establish and publish a  
22 naturopathic formulary that has been approved by the board for  
23 prescription, administration, or dispensing by naturopathic  
24 physicians" through Act 22, Special Session Laws of Hawaii 2009;  
25 and  
26

27 WHEREAS, the Board of Naturopathic Medicine established a  
28 naturopathic formulary effective January 1, 2010 that  
29 specifically prohibits the prescription, administration, or  
30 dispensation of formulary items "in injectable form or by  
31 injection unless this is specifically authorized by the Board's  
32 administrative rules"; and  
33

34 WHEREAS, however, the administrative rules of the Board of  
35 Naturopathic Medicine contain no provisions authorizing the  
36 prescription, administration, or dispensation of formulary items  
37 via parenteral therapy; and  
38

39 WHEREAS, the absence of administrative rules allowing the  
40 administration of parenteral therapy by naturopathic physicians  
41 effectively prohibits the practice; and  
42

43 WHEREAS, the intent of the Legislature in passing Act 22,  
44 Special Session Laws of Hawaii 2009, was to allow naturopathic



1 physicians to practice parenteral therapy pursuant to rules and  
2 subject to requirements established by the Board of Naturopathy;  
3 and  
4

5 WHEREAS, accordingly, Act 22 prohibits naturopathic doctors  
6 from performing parenteral therapy unless permitted to do so by  
7 administrative rules issued by the Board, and the Act's delayed  
8 effective date of January 1, 2010 was specifically intended to  
9 provide the Board adequate time to pass the requisite  
10 administrative rules; and  
11

12 WHEREAS, the effective prohibition on the use of parenteral  
13 therapy by naturopathic physicians that currently exists is in  
14 contradiction to the intent of the Legislature in passing Act 22  
15 and to the general and historical practice of naturopathic  
16 medicine in this State; now, therefore,  
17

18 BE IT RESOLVED by the Senate of the Twenty-fifth  
19 Legislature of the State of Hawaii, Regular Session of 2010, the  
20 House of Representatives concurring, that the Board of  
21 Naturopathic Medicine is urged to expeditiously adopt  
22 administrative rules in accord with Act 22, Special Session Laws  
23 of Hawaii 2009, to allow the use of parenteral therapy by  
24 naturopathic physicians that include education and training  
25 requirements; and  
26

27 BE IT FURTHER RESOLVED that the Board of Naturopathic  
28 Medicine is urged to immediately adopt rules that grandfather  
29 all persons licensed under chapter 455, Hawaii Revised Statutes,  
30 prior to January 1, 2010, and allow those persons to perform  
31 intramuscular, subcutaneous, and intravenous injection and  
32 prescribe, administer, and dispense naturopathic formulary  
33 substances manufactured for injection pending passage of the  
34 administrative rules; and

36 BE IT FURTHER RESOLVED that certified copies of this  
37 Concurrent Resolution be transmitted to the Board of  
38 Naturopathic Medicine and the Director of Commerce and Consumer  
39 Affairs.
