begs leave to report as follows:


Your Committee received testimony in support of this nomination from the Department of Commerce and Consumer Affairs and four private citizens. A personal statement and resume were received from the nominee. Written testimony presented to the Committee may be reviewed on the Legislature's website.

Upon review of the testimony, your Committee finds that the nominee's professional experience, commitment to public service, and proven leadership on the Motor Vehicle Industry Licensing Board qualify him for reappointment as a public member to the Motor Vehicle Industry Licensing Board. Your Committee notes that the nominee has over forty years experience in the insurance industry, including claims management, litigation management, and dispute resolution and special arbitration; all of which have contributed extensively to his work on the Board.
