Your Committee received testimony in support of Leo Maher, MD, MHA, FAAN, from the Department of Transportation. Written testimony presented to the Committee may be reviewed on the Legislature's website.

Dr. Maher is being reappointed to the Medical Advisory Board and represents the neurologist appointment. The nominee received a Bachelor of Science in Biology from Wayne State University and a Doctor of Medicine from Wayne State University School of Medicine. He is a member of the American Board of Psychiatry and Neurology, and was elected a Fellow of the American Academy of Neurology. The nominee is currently in private practice in Honolulu.
