Your Committee on Hawaiian Affairs, to which was referred
H.B. No. 1665 entitled:

"A BILL FOR AN ACT RELATING TO HAWAIIAN FISHPONDS,"

begs leave to report as follows:

The purpose of this bill is to protect access to Hawaiian
cultural and subsistence activities and resources by prohibiting
the Board of Land and Natural Resources from selling public land
on which government-owned Hawaiian fishponds are located.

The Kuli'ou'ou Kalani Iki Neighborhood Board #2, Livable
Hawaii Kai Hui, Maunalua Fishpond Heritage Center, Hawaii
Nearshore Fisherman and several concerned individuals supported
this bill. The Office of Hawaiian Affairs testified in support of
this measure and offered amendments. The Department of Land and
Natural Resources commented on this bill.

As affirmed by the record of votes of the members of your
Committee on Hawaiian Affairs that is attached to this report,
your Committee is in accord with the intent and purpose of H.B.
No. 1665 and recommends that it pass Second Reading and be
referred to the Committee on Water, Land, & Ocean Resources.
