Your Committee on Tourism, Culture, & International Affairs,
to which was referred H.B. No. 2317 entitled:

"A BILL FOR AN ACT RELATING TO THE STATE FOUNDATION ON
CULTURE AND THE ARTS,"

begs leave to report as follows:

The purpose of this bill is to enhance the fiscal stability
of the State Foundation on Culture and the Arts (SFCA) by allowing
moneys from the Works of Art Special Fund to fund the position
costs of the executive director of SFCA and other employees of
SFCA for a five-year period.

A concerned individual supported this bill. SFCA supported
the intent of this measure. Several concerned individuals
provided comments.

Your Committee has amended this bill by:

- (1) Changing the effective date to January 1, 2112, to
encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity,
consistency, and style.



As affirmed by the record of votes of the members of your Committee on Tourism, Culture, & International Affairs that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 2317, as amended herein, and recommends that it pass Second Reading in the form attached hereto as H.B. No. 2317, H.D. 1, and be referred to the Committee on Labor & Public Employment.
