Your Committee on Hawaiian Affairs, to which was referred
H.C.R. No. 104 entitled:

"HOUSE CONCURRENT RESOLUTION SUPPORTING H.R. 3680 AND S. 1732
TO AMEND THE PUBLIC HEALTH SERVICE ACT TO PROVIDE FOR HEALTH
DATA REGARDING NATIVE HAWAIIANS AND OTHER PACIFIC ISLANDERS,"

begs leave to report as follows:

The purpose of this concurrent resolution is to improve the
evaluation of healthcare needs of native Hawaiians and other
Pacific Islanders by expressing the Legislature's support for the
passage in Congress of H.R. 3680 and S. 1732, amending the federal
Public Health Service Act to provide for health data regarding
native Hawaiians and other Pacific Islanders.

The Association of Hawaiian Civic Clubs and Hawaii Youth
Services Network testified in support of this concurrent
resolution.

Your Committee has amended this concurrent resolution by
capitalizing the word "native" in all references to "native
Hawaiian", as suggested by a testifier, with the intent that the
data obtained will assist all Native Hawaiians, regardless of
blood quantum.



As affirmed by the record of votes of the members of your Committee on Hawaiian Affairs that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 104, as amended herein, and recommends that it be referred to the Committee on Tourism, Culture, & International Affairs in the form attached hereto as H.C.R. No. 104, H.D. 1.
