Your Committee on Tourism, Culture, & International Affairs,
to which was referred H.C.R. No. 166 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE HAWAII TOURISM
AUTHORITY, IN COLLABORATION WITH THE HAWAII BOXING
COMMISSION, TO CONDUCT A STUDY TO DETERMINE THE FEASIBILITY

begs leave to report as follows:

The purpose of this concurrent resolution is to request the
Hawaii Tourism Authority (HTA), in collaboration with the Hawaii
Boxing Commission, to conduct a study to determine the feasibility
of bringing world-class boxing events to Hawaii.

The Hawaii State Boxing Commission and a concerned individual
supported this concurrent resolution. HTA provided comments.

Your Committee has amended this concurrent resolution by:


- (1) Amending its title to read: "REQUESTING THE HAWAII
TOURISM AUTHORITY, IN COLLABORATION WITH THE HAWAII
BOXING COMMISSION AND OTHER RELATED PARTIES, TO CONTINUE
TO PURSUE BRINGING WORLD-CLASS BOXING EVENTS TO HAWAII";
- (2) Requesting HTA to continue to pursue bringing world-
class boxing events to Hawaii, instead of conducting a
study;



- (3) Adding the Chief Executive Officer of Top Rank and President of Golden Boy Promotions to the list of recipients of certified copies of the concurrent resolution; and
- (4) Making technical, nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Tourism, Culture, & International Affairs that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 166, as amended herein, and recommends that it be referred to the Committee on Finance in the form attached hereto as H.C.R. No. 166, H.D. 1.
