Your Committees on Agriculture and Water, Land, & Ocean Resources, to which was referred H.C.R. No. 184 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THAT THE LEGISLATURE CONVENE AN INVESTIGATORY PUBLIC HEARING TO EVALUATE THE BIOSECURITY PROGRAM BY EXAMINING STATE AND COUNTY POLICIES AND PRACTICES THAT AFFECT THE AVAILABILITY OF WATER FOR AGRICULTURE AND MAINTENANCE OF AGRICULTURAL IRRIGATION SYSTEMS,"

- (2) Identify any statutory or other amendments that may be necessary to promote and meet the objectives of the biosecurity program.

Agribusiness Development Corporation, Hawaii Council of Mayors, Hawaii Crop Improvement Association, ILWU Local 142, Kauai Taro Growers Association, Kauai County Farm Bureau, Hui O Ka Ike, Hawaii Cattlemen's Council, and a multitude of concerned individuals testified in support of this concurrent resolution.

Land Use Research Foundation of Hawaii and Hawaii Farm Bureau Federation supported the intent of this measure. Concerned individuals opposed this concurrent resolution. The Department of Agriculture provided comments.
