Your Committee on Hawaiian Affairs, to which was referred H.C.R. No. 245 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE OFFICE OF HAWAIIAN AFFAIRS WITH THE ASSISTANCE OF THE BERNICE PAUHI BISHOP MUSEUM TO DEVELOP A PLAN TO IMPLEMENT REPLICAS OF HAWAIIAN HALE ON THE STATE CAPITOL LAWN SURROUNDED BY TROPICAL FOLIAGE FOR REST AREAS,"

The purpose of this concurrent resolution is to request the Office of Hawaiian Affairs (OHA), with the assistance of the Bernice Pauahi Bishop Museum, to develop a plan to implement replicas of Hawaiian hale surrounded by tropical foliage for rest areas on the state capitol lawn.
