The purpose of this concurrent resolution is to approve the  
sale of certain state land pursuant to Act 176, Session Laws of  
Hawaii 2009. Specifically, the Hawaii Housing and Finance  
Development Corporation (HHFDC) seeks to sell in fee simple a  
residence located at 1051 Onaha Street, Wailuku, Hawaii, TMK No.  
2-3-3-16-11, to a qualified resident as defined in section 201H-  
32, Hawaii Revised Statutes. HHFDC obtained this property through  
use of its rights under its deferred sales price restriction on  
homes developed under the expedited development process.

HHFDC testified in support of this concurrent resolution.

Your Committees find that a public informational briefing was  
duly conducted on the sale of this property and no objection was  
received.


As affirmed by the records of votes of the members of your
