Your Committee on Hawaiian Affairs, to which was referred H.C.R. No. 8 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THAT PORTRAITS OF OFFICIALS OF THE PROVISIONAL GOVERNMENT OF HAWAI'I BE REMOVED FROM DISPLAY IN POSITIONS OF HONOR IN STATE GOVERNMENT BUILDINGS,"
