The purpose of this measure is to provide immunity from  
liability and coverage of medical expenses for licensed medical  
personnel providing volunteer services on behalf of the State or a  
county in non-emergency situations, such as school-based  
immunization clinics.

Your Committee received testimony in support of this measure  
from the Department of Health, the University of Hawaii John A.  
Burns School of Medicine, and two individuals.

on the Legislature's website.


Your Committee finds that this measure will encourage

and recommends that it pass Second Reading and be referred to the Committee on Judiciary and Government Operations.


