Your Committee on Water, Land, Agriculture, and Hawaiian Affairs, to which was referred S.C.R. No. 77 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE AUDITOR TO CONDUCT A FOLLOW-UP AUDIT OF THE MANAGEMENT OF STATE BOATING FACILITIES BY THE DIVISION OF BOATING AND OCEAN RECREATION OF THE DEPARTMENT OF LAND AND NATURAL RESOURCES,"

begs leave to report as follows:

The purpose of this measure is to request the Auditor to conduct a follow-up audit of the management of state boating facilities by the Division of Boating and Ocean Resources of the Department of Land and Natural Resources.

Testimony in support of this measure was submitted by one private organization and four individuals. Testimony in opposition of this measure was submitted by one state agency and one individual. Comments on this measure were submitted by one individual. Written testimony presented to the Committee may be reviewed on the Legislature's website.

Your Committee finds that it is imperative to protect the financial resources that are available to maintain and repair the harbor and boating facilities throughout the State. Your Committee also finds that requesting the Auditor to conduct a follow-up audit to previous audits completed in 2001 and 2006 relating to state boating facilities and the Division of Boating and Ocean Resources respectively, will enable the Department of Land and Natural Resources to assess its internal division needs



more accurately and assist the Department in achieving its mission and objectives more effectively.

As affirmed by the record of votes of the members of your Committee on Water, Land, Agriculture, and Hawaiian Affairs that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 77 and recommends that it be referred to the Committee on Ways and Means.
