<u>SB 2285</u> <u>Testimony</u> <u>Status</u>	RELATING TO PRE-NEED FUNERAL PLANS. Requires the deposit into trust of one hundred per cent of all funds paid to purchase a pre-need funeral plan plus all interest earned. Allows a cemetery or pre-need authority to deduct certain allowable expenses from a trust. Requires annual statements of the disposition of trust funds.	CPN
<u>SB 2516</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE FUNERAL INDUSTRY. Creates a standardized form for cemetery and pre-need funeral authorities' financial statements and actuarial reports. Ensures sufficient funds are available to cover future claims. Requires the department of commerce and consumer affairs to report to the legislature on the status of licensees required to submit audited financial statements and actuarial reports.	CPN
<u>SB 2016</u> <u>Testimony</u> <u>Status</u>	RELATING TO LIFE SETTLEMENTS. Extends the Life Settlements Act for an additional five years.	CPN
<u>SB 2596</u> <u>Testimony</u> <u>Status</u>	RELATING TO GROUP LIFE INSURANCE. Specifies conditions for group life insurance policies offered or delivered within the State.	CPN
<u>SB 2669</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE SOLICITATION OF FUNDS FROM THE PUBLIC. Amends chapter 467B, Hawaii Revised Statutes, to allow service of process by substitute service, allows the Attorney General to accept assurances of discontinuance, and amends and clarifies the charity registration exemptions, and clarifies the time period for the filing of a charity's annual financial report. Requires athletic trainers to register with the department of commerce and consumer affairs.
