<u>SB 2163, SD1</u> <u>(SSCR2302)</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE PRACTICE OF NURSING. Defines the practice of nursing; directs the state board of nursing to adopt certain provisions of the NCSBN Model Nursing Practice Act and Model Nursing Administrative Rules; delineates the scope of practice for registered nurses, licensed practical nurses, and advanced practice registered nurses; repeals Hawaii Administrative Rules relating to prescriptive authority for advanced practice registered nurses and amends the definition of "advanced practice nurse with prescriptive authority" to reflect this. (SD1)	HTH, CPN
<u>SB 2491, SD1</u> <u>(SSCR2139)</u> <u>Testimony</u> <u>Status</u>	RELATING TO TELEMEDICINE. Clarifies telehealth as a practice of medicine. Amends liability insurance provisions to allow for telehealth coverage under medical malpractice insurance. Effective 7/1/50. (SD1)	HTH, CPN
<u>SB 2390, SD1</u> <u>(SSCR2208)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PHARMACIST LICENSURE. Broadens the practical experience requirements for a pharmacist license to include experience obtained in U.S. territories and the District of Columbia. Removes the requirement that supervision must take place in a pharmacy. Broadens the experience requirements to relate to the practice of pharmacy. (SD1)	HTH/HRE, CPN
<u>SB 2770, SD1</u> <u>(SSCR2303)</u> <u>Testimony</u> <u>Status</u>	RELATING TO REMOTE DISPENSING PHARMACY. Clarifies the definitions of "remote dispensing machine" and "remote dispensing pharmacy". (SD1)	HTH, CPN

<p><u>SB 2811, SD1</u> <u>(SSCR2304)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO PHARMACIES. Requires all pharmacies and remote dispensing pharmacies to have the capacity to accommodate electronic prescriptions. Requires all pharmacies and dispensing pharmacies to maintain prescription records electronically. Effective 7/1/50. (SD1)</p>	<p>HTH, CPN</p>
<p><u>SB 2102, SD1</u> <u>(SSCR2207)</u> <u>Testimony</u> <u>Status</u></p>	<p><u>RELATING TO PRESCRIPTION DRUGS.</u> <u>Requires providers of accident or health and sickness insurance to base prescription drug coverage a drug formulary or prior authorization requirements established and regularly updated by a drug formulary advisory board whose membership includes a majority of Hawaii residents or practitioners. Effective 7/1/50. (SD1)</u></p>	<p><u>HTH, CPN</u> [Measure Added: 02/16/10]</p>
<p><u>SB 2343, SD1</u> <u>(SSCR2068)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO INSURANCE COVERAGE FOR MAMMOGRAMS. Prohibits an insurer from requiring a doctor's referral for annual mammograms for covered individuals over forty years old. (SD1)</p>	<p>HTH, CPN</p>
<p><u>SB 2371, SD1</u> <u>(SSCR2067)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO LIMITED BENEFIT HEALTH INSURANCE. Excludes limited benefit health insurance and medicare supplements from provisions of chapter 431:10A enacted after July 1, 2010. (SD1)</p>	<p>HTH, CPN</p>
<p><u>SB 2698</u> <u>(SSCR2260)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO INSURANCE. Mandates the offer of health insurance coverage for dependents up to age 27 at the option of the parents. (SD1)</p>	<p>HTH, CPN</p>
<p><u>SB 2271, SD1</u> <u>(SSCR2258)</u> <u>Testimony</u> <u>Status</u></p>	<p><u>RELATING TO HEALTH INSURANCE PREMIUMS.</u> <u>Increases health insurance premium transparency, requires an annual premium transparency report, and creates a health information data clearinghouse; requires a minimum amount of premiums to be spent on medical expenses. Effective date 7/1/50. (SD1)</u></p>	<p><u>HTH, CPN</u> [Measure Added: 02/16/10]</p>
<p><u>SB 2188</u> <u>(SSCR2137)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO DENTISTRY. Redefines the practice of dentistry to include teeth whitening.</p>	<p>HTH, CPN</p>
<p><u>SB 2126, SD1</u> <u>(SSCR2259)</u> <u>Testimony</u> <u>Status</u></p>	<p><u>RELATING TO DENTAL SERVICES.</u> <u>Prohibits an accident and health or sickness insurer, mutual benefit society, health maintenance organization, or dental service organization from requiring a dentist who provides services to its subscribers to accept a fee set by the accident and health or sickness insurer, mutual benefit society, health maintenance organization, or dental service organization unless the services are covered under the applicable subscriber agreement. Effective 7/1/50. (SD1)</u></p>	<p><u>HTH, CPN</u> [Measure Added: 02/16/10]</p>
