<u>SB 2327</u>	RELATING TO CIVIL SERVICE.	EDH/LBR, WAM
<u>Testimony</u>	Ensures that the civil service benefits of department of education civil service employees are the same as those provided to civil service employees of other executive branch agencies.	
<u>Status</u>		
<u>SB 2470</u>	RELATION TO EDUCATION.	EDH/LBR, WAM
<u>Testimony</u>	Requires all public schools, including charter schools, to implement a minimum of two hundred days of classroom instruction per school year. Prohibits any collective bargaining agreement under chapter 89, Hawaii Revised Statutes, from containing provisions that would shorten the school year for public school employees to less than two hundred days of classroom instruction per school year.

<u>SB 2797</u>	RELATING TO VOLUNTARY EMPLOYEES' BENEFICIARY ASSOCIATION TRUSTS.	EDH/LBR, WAM
<u>Testimony</u>	Makes permanent the voluntary employees' beneficiary association trusts, established in 2005 as a temporary program.
