<u>HB 2833</u> <u>(HSCR128-10)</u> <u>Status</u>	RELATING TO PUBLIC LANDS. Authorizes the board of land and natural resources to extend a lease of public lands for commercial, hotel, resort, or industrial uses for 55 years upon a development agreement to improve the land.	WLO, FIN
<u>HB 2923, HD1</u> <u>(HSCR165-10)</u> <u>Status</u>	RELATING TO PUBLIC LANDS. Authorizes the Department of Hawaiian Home Lands to extend leases of Hawaiian home lands for commercial or industrial uses for 34 years upon a development agreement to improve the leased land.	WLO/TCI, FIN
<u>HB 2845</u> <u>(HSCR313-10)</u> <u>Status</u>	RELATING TO LANDS CONTROLLED BY THE STATE. Exempts the fee simple resale of individual dwelling units acquired by the Hawaii housing finance and development corporation pursuant to foreclosure or a buyback provision from legislative approval requirements.	WLO/HSG, FIN
<u>HB 2561</u> <u>(HSCR273-10)</u> <u>Status</u>	RELATING TO LANDS CONTROLLED BY THE STATE. Restores the law with regard to non-ceded lands controlled by the State, to what it was prior to the passage of Act 176, Session Laws of Hawaii 2009.	WLO, FIN
<u>HB 1808, HD2</u> <u>(HSCR205-10)</u> <u>Status</u>	RELATING TO COASTAL AREAS. Requires maintenance of public beach accesses by adjacent landowners and imposes penalties for noncompliance. Establishes shoreline access as a policy of the Coastal Zone Management Program. Effective November 1, 2010.	WLO, JUD, FIN

PAPER: 2 copies to Room 306 in the State Capitol;


