HB 2347, HD1  
(HSCR67-10)  
Status

RELATING TO THE MAXIMUM TERM OF COMMERCIAL USE AND OPERATOR PERMITS FOR THRILL CRAFT AND PARASAILING. WLO, FIN  
Removes the twenty-year limit for state parasailing and thrill craft permits, and makes those permits renewable annually. Directs DLNR to offer for public auction permits that have been revoked for cause.

HB 2582  
(HSCR251-10)  
Status

RELATING TO VESSELS AT ALA WAI AND KEEHI BOAT HARBORS. WLO, FIN  
Authorizes moorage for commercial vessels and commercial vessel activities in the Ala Wai and Keehi Boat Harbors and adjusts fees for permittees of vessels that are used for a place of principal habitation in state small boat harbors.


