RELATING TO HEALTH.

HMS/CPN, WAM

Exempts government-contracted health plans from paying interest under the Clean Claims Law when delays are due to non-payment by government payers to the plans. Clarifies the exemption for Medicaid and Medigap claims. Effective January 1, 2050. (HB2087 HD1)

Please note: If you submit your written testimony after 4:00 p.m. the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.
