<u>Testimony</u>	Authorizes pharmacists to provide medication therapy management to qualified patients. Requires pharmacies to maintain prescription records and medication therapy management records electronically.

RELATING TO ANATOMICAL GIFTS.

HTH/CPN, JGO

Requires organ procurement organizations and transplant hospitals to procure and transplant medically suitable organs. Imposes administrative fines and loss of accreditation for failure to comply.

Decision Making to follow, if time permits.

Please note: If you submit your written testimony after 4:00 p.m. the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.
