<a href="#">SB 2148</a> <a href="#">Testimony</a> <a href="#">Status</a>	RELATING TO THE JUDICIARY. Appropriates funds to the Judiciary for FY 2010-2011.	JGO, WAM
<a href="#">SB 2157</a> <a href="#">Testimony</a> <a href="#">Status</a>	RELATING TO ADMINISTRATIVE LICENSE REVOCATION. Shifts costs of mailing administrative hearing request from the driver's license revocation office to the person requesting the hearing. Increases the administrative hearing fee from \$30 to \$50.	JGO, WAM
<a href="#">SB 2159</a> <a href="#">Testimony</a> <a href="#">Status</a>	RELATING TO TRAFFIC ABSTRACT FEE. Increases the fee for a traffic abstract from \$7 to \$10 and increases the amount of the fee deposited into the general fund from \$5 to \$8.	JGO, WAM
<a href="#">SB 2161</a> <a href="#">Testimony</a> <a href="#">Status</a>	RELATING TO WITNESSES. Increases the per diem payments for out-of-state witnesses in criminal cases from \$110 to \$145. Provides an additional \$90 per diem payment for witnesses from any island other than the island on which the court is located, when that witness is required to stay overnight.	JGO, WAM
<a href="#">SB 2454</a> <a href="#">Testimony</a> <a href="#">Status</a>	RELATING TO PUBLIC AGENCY MEETINGS AND RECORDS. Allows courts to charge fees for certified copies of pleadings, orders, transcripts, and other documents.	JGO, WAM
<a href="#">SB 2469</a> <a href="#">Testimony</a> <a href="#">Status</a>	<u>RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.</u> <u>Appropriates moneys from the emergency and budget reserve fund to maintain levels of programs for education, human services, health.</u>	<u>HMS/HTH/JGO.</u> <u>WAM</u> <u>[Measure added 02-04-10]</u>
