<u>SB 2378, SD1</u> <u>(SSCR2122)</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS. Provides for the election of the office of Hawaiian affairs board members through a system of nonpartisan primary and general elections. (SD1)	WTL, JGO
